RESOLUTION ADOPTING NEW
CONFLICT OF INTEREST CODE

BE IT RESOLVED BY THE HOUSING AUTHORITY OF THE CITY
OF SACRAMENTO:

Section 1. The Conflict of Interest Code which has been promulgated as Title II, Division 6 of the California Administrative Code (Section 18730, et seq.) is hereby adopted as the Conflict of Interest Code of the Housing Authority of the City of Sacramento. Revisions or amendments of the aforementioned code sections as they may from time to time occur in the future shall be deemed to amend the Conflict of Interest Code of the Housing Authority of the City of Sacramento.

Section 2. The appendix of the aforementioned Conflict of Interest Code shall be as follows:

"Appendix - Persons holding all of the following positions shall make investment and real property disclosures, personal income disclosures, business entity income disclosures, and business position disclosures, as required and in the manner prescribed by this code.


