SUBJECT: REQUEST FOR A RESOLUTION AUTHORIZING AN INCREASE IN THE LIBRARY'S BUDGET BY \$2,518, THE AMOUNT RECEIVED FROM A GRANT UNDER THE LIBRARY SERVICES AND CONSTRUCTION ACT

SUMMARY:

In April, 1981, the Library was awarded a grant of \$2,518 by the California State Library under the Library Services and Construction Act (LSCA), as a major urban library source, serving a population of 100,000 or more.

BACKGROUND:

When the Library Services and Construction Act came before Congress for its five-year renewal in 1977, the Urban Libraries Council sponsored an amendment specifically intended to assist city libraries with their financial needs. Twenty-one cities in California have a population of over 100,000; the libraries serving these areas were eligible to apply for MURL assistance.

Application was made to the California State Library for a grant to purchase backfiles of periodicals in microfilm form and have them available by printout in hard copy, replacing back copies and freeing warehouse space for the Library Department.


FUNDING:

Approval and award of the grant to the Library provides for administration of funds by the City of Sacramento as Fiscal Agent. There is no obligation on the part of the City of Sacramento to participate in the support of the program.


RECOMMENDATION:
