

Sacramento, California,

March 10, 1931.

The Civil Service Board of the City of Sacramento met in special session on the above date at 7:00 o'clock P. M. in the office of the Board, Room 106 City Hall, President Chenu presiding.

PRESENT: Commissioners Maloney, Weisman, and Chenu.
ABSENT : None.

The reading of the minutes of the previous meetings was dispensed with.

A communication was received from James Gerard employed by the City as a Janitor, requesting information regarding his status. The employment record of Mr. Gerard showed that he had been in the employ of the city since June 24, 1929. Mr. Gerard was separated from the Recreation Department November 17, 1930. Mr. George Sim, Superintendent of the Recreation Department, appeared before the Board upon request in connection with this case. Mr. Gerard and Mr. Perry, the latter an employee of the Recreation Department, appeared. Commissioner Maloney moved that this case be taken under advisement. The motion was seconded by Commissioner Weisman. The vote was as follows:

AYES: Commissioners Maloney, Weisman, and Chenu.
NOES: None.

~~Mr. Boltz appeared before the board in reference to the taking of notes in connection with the recent questioning of Mr. Angelo. The secretary of the board explained the reason for this action and stated it was not the intention to surround the taking of these notes with secrecy, and offered an apology for not making it known that notes would be taken.~~

Mr. Arthur Leiva appeared before the Board with reference to the status of A. J. Angelo.

The case of A. J. Angelo was considered by the Board. After investigating the records covering the case, Commissioner Maloney offered the following resolution and moved its adoption:

WHEREAS, from the records available, it is shown that Mr. A. J. Angelo was working as a Stoker at the Incinerator May 25, 1925, at the rate of \$125.00 per month; that Mr. Angelo while working in the above capacity was changed to a position carrying the classification of Laborer,

AND WHEREAS, in the opinion of the Civil Service Board, Mr. Angelo was deprived of his proper classification,

NOW, THEREFORE, BE IT RESOLVED that Mr. Angelo be and he is hereby restored to his proper classification of Stationary Fireman.

The motion to adopt the resolution was seconded by Commissioner Weisman. The vote was as follows:

AYES: Commissioners Maloney, Weisman, and Chenu.
NOES: None.

Mr. James S. Dean, City Manager, appeared before the Board concerning the temporary appointment of Mr. Haengi to supervise tree spraying work. The Board advised the City Manager no action on the part of the Board was necessary at this time, and that the regular procedure in making temporary appointments should be followed.

The Board next discussed the present classification of Mechanic. Commissioner Maloney moved that the classification be abolished. The motion was seconded by Commissioner Weisman. The vote was as follows:

AYES: Commissioners Maloney, Weisman, and Chenu.
NOES: None.

The request of Mrs. M. B. White for a consideration of her employment record and a determination made as to her service was taken up. Commissioner Maloney moved that, in view of the facts before the Board, the record of Mrs. White be made to read from the date of her first employment by the city; namely, July 1, 1915, and her service be considered as continuous from that date until the present time with the exception of one year, 1920, when she was absent from the city service. The motion was seconded by Commissioner Weisman. The vote was as follows:

AYES: Commissioners Maloney, Weisman, and Chenu.
NOES: None.

The case of Lowell Moffitt, requesting further consideration of the grade received in part of the recent test for Uniform Fireman, under advisement by the Board was considered. Commissioner Weisman moved that Mr. Moffitt's request be denied. The motion was seconded by Commissioner Maloney. The vote was as follows:

AYES: Commissioners Maloney, Weisman, and Chenu.
NOES: None.

Commissioner Maloney moved that the Secretary be instructed to communicate the action of the Board with reference to the classification of Mechanic to the City Manager, and that it be stated in the letter of transmittal that the Board will not recognize this classification after April 1, 1931. The motion was seconded by Commissioner Weisman. The vote was as follows:

AYES: Commissioners Maloney, Weisman, and Chenu.
NOES: None.

The Board next considered the status of Mr. George Mento, an employee of the city in the Health Department. After consideration

of the facts in the case, Commissioner Maloney offered the following resolution and moved its adoption:

WHEREAS, in the reclassification adopted by the Civil Service Board June, 1928, Mr. George Mento, an employee of the Health Department, was classified as a Senior Clerk,

AND WHEREAS, the Civil Service Board upon investigation finds that this classification does not properly cover the duties of the position and is in error,

NOW, THEREFORE, BE IT RESOLVED that Mr. George Mento be and he is hereby classified as a Sanitary Inspector in the Food and Market Division of the Health Department.

The motion was seconded by Commissioner Weisman. The vote was as follows:

AYES: Commissioners Maloney, Weisman, and Chenu.
NOES: None.

The appointments covering Roy V. Wise, Veander Tillman, and ~~L. O. Kirchgater~~ ^{A. H. H. H.} was considered. Commissioner Maloney moved that these men be separated from the city service and eligibles from the appropriate lists be appointed. The motion was seconded by Commissioner Weisman. The vote was as follows:

AYES: Commissioners Maloney, Weisman, and Chenu.
NOES: None.

Adjournment was taken at 10:45 o'clock P. M. to meet again at the call of the Chair.
