

ORDINANCE NO. 1564, FOURTH SERIES.

AN ORDINANCE AMENDING SUBDIVISION 3 OF SECTION 3 OF ORDINANCE NO. 669, FOURTH SERIES, PASSED JUNE 27, 1935, AND ENTITLED: "AN ORDINANCE PROVIDING FOR THE LICENSING AND REGULATION OF DANCING IN PLACES WHERE LIQUORS ARE SOLD, PROVIDING A PENALTY FOR VIOLATION OF THIS ORDINANCE; REPEALING SECTION 4 OF ORDINANCE NO. 317, THIRD SERIES, PASSED OCTOBER 11, 1917; AND MAKING THIS ORDINANCE AN EMERGENCY MEASURE TO TAKE EFFECT IMMEDIATELY," AND MAKING THIS ORDINANCE AN EMERGENCY MEASURE TO TAKE EFFECT IMMEDIATELY.

BE IT ENACTED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

SECTION 1: Subdivision 3 of Section 3 of Ordinance No. 669, Fourth Series, passed June 27, 1935, is hereby amended to read as follows:


Subdivision 3: The area bounded as follows: Commencing at a point on the center line of 3rd Street 665½ feet south of the center line of Broadway; thence in an easterly direction parallel to the center line of Broadway to the west boundary line of the property occupied by the New Helvetia Housing Project; thence northerly along the west boundary of the New Helvetia Housing Project to the point of intersection of the center line of Broadway with the west boundary line of the New Helvetia Project extended; thence in an easterly direction to the intersection of the center lines of Broadway and 9th Streets; thence easterly from a point at the center line of Broadway and 9th Street along the center line of Broadway to a point 80' east of the east property line of 10th Street; thence northerly and in a projected line parallel to 10th Street to a point in the center line of "W" Street; thence westerly along the center line of "W" Street to a point at the center line of 10th and "W" Streets; thence southerly along the center line of "W" Street to the north property line of 10th Street and Broadway; thence westerly along the northerly property line of Broadway to 9th Street; thence to a point on the center line of 9th Street 200 feet north of the intersection of the center line of Broadway with the center line of 9th Street; thence in a westerly direction parallel to the center line of Broadway to the center line of 3rd Street; thence along the center line of 3rd Street to the point of beginning.

SECTION 2: This ordinance is hereby declared to be an emergency measure and shall take effect immediately; such emergency being the necessity of changing the district in Subdivision 3 to include the property at No. 2315-10th Street, Sacramento, California.


