

MINUTES OF CIVIL SERVICE BOARD  
CITY OF SACRAMENTO  
SPECIAL MEETING

November 21, 1933

The Civil Service Board met in special session in the office of the Board, Room 106, City Hall, at 8:05 o'clock P.M., President Weisman presiding.

PRESENT: Commissioner Chenu, President Weisman.  
ABSENT : Commissioner Deise.

The minutes of the special meetings of October 17, 1933; October 24, 1933, and October 27, 1933, were read and, there being no corrections, were ordered approved as read.

UTT, DR. JAMES  
CANCELLING RESIGNATION

A letter from Dr. Utt, Assistant Meat Inspector in the Health Department, dated October 3, 1933,

was read to the Board. Dr. Utt explained his periods of past employment with the city, stating that he had resigned May 19, 1921, to regain his health at the suggestion of Commissioner Bliss and Dr. Megowan. Due to the nature of his resignation, Dr. Utt requested that the Board permit him to be credited with his service prior to his resignation.

After a full discussion of the matter, the Board requested the Secretary to write Dr. Utt and inform him that it would be impossible for his request to be granted because of decisions and advise from the City Attorney that service of city employees prior to a date of resignation could not be credited to an employee's record.

SENIOR CLERK PROMOTIONAL EXAM. ASSESSOR-COLLECTOR OFFICE A letter from E. H. Nelson,

November 21, 1933.

Assessor-Collector, dated November 16, 1933, was read. Mr. Nelson

recommended that a departmental promotional examination be given for the position of Senior Clerk. After discussion, the Secretary was instructed to refer the matter to the City Manager to determine if in his opinion it would be for the good of the service for the Board to proceed with this examination.

LEE, P. J.  
REINSTATEMENT

A letter from P. J. Lee, dated November 14, 1933, addressed to Mr. Charles Chenu, City Civil

Service Commission, was read. Mr. Lee previously was a city employee and in his letter requested that he be granted a re-hearing on his case, apparently as considered by the Board January 19, 1933. After considerable discussion and review of his records, the Board instructed the Secretary to notify Mr. Lee that the provisions of the Rules and Regulations would not permit them to change their previous decision.

FREI, JOHN  
LABORERS ELIGIBLE REGISTER

Mr. Frei appeared before the Board and explained that he could not understand why his

name appeared only upon Group No. 2 of the Laborers Eligible list effective January 21, 1931. After reviewing Mr. Frei's record and after discussing his personal fitness qualifications, Commissioner Chenu moved that Mr. Frei's name be placed upon Group No. 1, Laborer's Eligible Register No. 64, in accordance with the percentage he had received in Group No. 2. Seconded by President Weisman and carried with the following vote:
