SUBJECT: 926 J Street - Revocable Encroachment Permit

SUMMARY

The Director of Public Works recommends that a Revocable Encroachment Permit be granted to the 926 J Street Partnership for the purpose of installing counter balanced stairs on the existing exterior fire escape.

BACKGROUND

The 926 J Street Partnership has applied for a Revocable Encroachment Permit for the purpose of installing counter balanced stairs at 926 J Street.

The encroachment area is 3'8" into the alley and 27' in length at a height of 14'6" located on the south side of 926 J Street.

RECOMMENDATION

The Director of Public Works recommends that the attached resolution be passed granting a Revocable Encroachment Permit to 926 J Street Partnership for the area and for the purpose outlined above.

RESOLUTION NO. 87-794

ADOPTED BY THE SACRAMENTO CITY COUNCIL ON DATE OF

RESOLUTION GRANTING REVOCABLE ENCROACHMENT PERMIT TO:

926 J STREET PARTNERSHIP

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

That a Revocable Encroachment Permit be granted to 926 J Street Partnership, whose address is 926 J Street, Sacramento, California, for the purpose of the installation of counter balanced stairs. Said Revocable Permit shall pass on to any successor in title of the adjoining property. This encroachment is described as follows:

Counter balanced stairs encroaching 3'8" into the alley and 27' in length at a height of 14'6" located on the south side of 926 J Street.

This permit is granted subject to the "General Provisions - Revocable Encroachment Permit", which were adopted by the City Council in Resolution No. 81-845 dated November 17, 1981. This permit shall be effective only after the applicant files the insurance certificates, required by the General Provisions, with the Risk Management and Insurance Division of the City of Sacramento.
