1. To purchase additional buses, to replace buses with an average age of 13 years.
2. To establish an operating reserve and a capital development fund.
3. To make service improvements.

Chair Robie noted that the maintenance crew of regional transit achieved an award for outstanding maintenance.



Chair Robie asked that when the Committee meets again in January that a member of Supervisor Grantland Johnson's staff be present.
