Description/Analysis

Issue Detail: On January 22, 2019, City Council adopted Resolution No. 2019-0013 increasing the number of members of the Personnel and Public Employees Committee from three members and one alternate member to four members. Additionally, on January 22, 2019, City Council adopted Resolution No. 2019-0014 confirming Mayoral Appointments to the Personnel and Public Employees Committee declaring Councilmembers Angelique Ashby, Steve Hansen, and Larry Carr and Mayor Darrell Steinberg shall serve on the Personnel and Public Employees Committee.

On March 26, 2019, the Mayor announced reducing the number of councilmembers on the Personnel and Public Employees Committee from four members to three members. Tonight, City Council will be confirming the updated 2019 Mayoral Appointments to Standing Committees and Regional Authorities, Agencies, and Committees. To incorporate the Personnel and Public Employees Committee membership adjustment into the updated 2019 Mayoral Appointments roster, a resolution must be passed officially reducing the number of councilmembers on the Personnel and Public Employees Committee from four members to three members as proposed.

Policy Considerations: The Personnel and Public Employees Committee will conduct its business in the same manner as the other three Council standing committees and is subject to the Brown Act. The selection to the Personnel and Public Employees Committee is the same for the three existing standing committees – councilmembers appointed by the Mayor and confirmed by the Council on an annual basis or as needed – however the Personnel and Public Employees Committee will be comprised of three Councilmembers and one alternate Councilmember in the same manner as the Water Committee. The Council Rules of Procedure set forth the guidelines for the Personnel and Public Employees Committee as well as set the purpose and procedures for the operation of the Personnel and Public Employees Committee.

Rationale for Recommendation: The proposed action reduces the number of Councilmembers sitting on the Personnel and Public Employees Committee from four members to three members.

RESOLUTION NO. 2019-

Adjustment of Membership for Personnel and Public Employees Committee

BACKGROUND

- A. On January 22, 2019, City Council adopted Resolution No. 2019-0013 increasing the number of members of the Personnel and Public Employees Committee from three members and one alternate member to four members.
- B. On January 22, 2019, City Council adopted Resolution No. 2019-0014 confirming Mayoral Appointments to the Personnel and Public Employees Committee declaring Councilmembers Angelique Ashby, Steve Hansen, and Larry Carr and Mayor Darrell Steinberg shall serve on the Personnel and Public Employees Committee.
- C. On March 26, 2019, the Mayor announced adjusting the number of sitting members on the Personnel and Public Employees Committee from four to three members.

BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:

- Section 1. The Personnel and Public Employees Committee shall consist of three councilmembers who shall be appointed annually or as needed by the Mayor and confirmed by the City Council.
- Section 2. Unless in conflict with this resolution, the Personnel and Public Employees Committee is subject to the Brown Act and the Council Rules of Procedure.
- Section 3. The Purpose of the Personnel and Public Employees Committee is to:
 - a. Review applications received for membership to various city boards, commissions, and committees.
 - b. Conduct interviews for such membership appointment.
 - c. Make recommendations to the mayor concerning such appointments.

- Section 4. The Personnel and Public Employees Committee shall review applications for boards, commissions, and committees. Recommendations by the Personnel and Public Employees Committee shall be submitted to the city clerk for distribution to the mayor.
- Section 5. The mayor, or the city clerk on the mayor's behalf, shall announce appointments at the council meeting during Council Ideas, Comments, and Questions.
- Section 6. After the mayor's nominations, the city clerk shall submit a report for the council agenda requesting confirmation of the mayor's nominations.
- Section 7. A vote of the majority of members present is required to forward Personnel and Public Employees Committee appointment recommendations to the council, in accordance with Chapter 14 of the Council Rules of Procedure.
- Section 8. Resolution No. 2019-0013 is rescinded.
