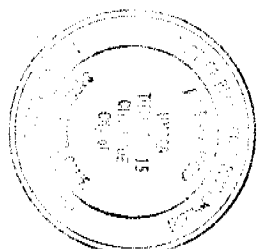

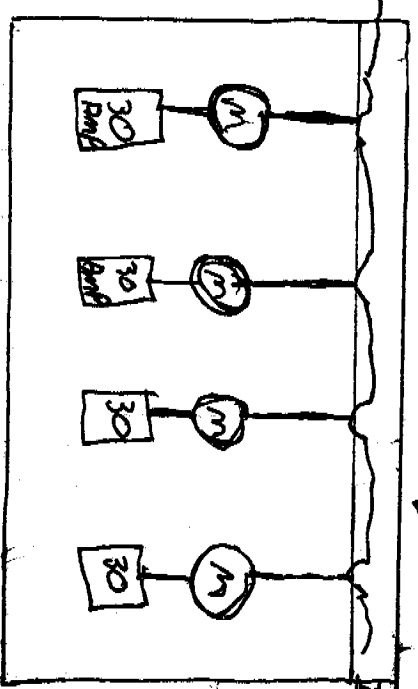
New #4 Copper Feeders
