Pursuant to your request, Anderson Engineering Consultants performed a visual structural inspection at the subject site on September 4, 1997. The roof structure is comprised of 2x4 Douglas fir gangnail trusses spaced at 24" o.c. at a 4:12 pitch and have a 1750 psi stress grading. The roof structure was found to be in sound condition.

It is our opinion, based on the site inspection, that the structural integrity of the roof system will not be compromised by using your proposed reroof system using lightweight Monier tile weighing 5.8 psf.
