SUBJECT: Extending Time on Contract for Greenhaven Drive

BACKGROUND INFORMATION

The Council awarded a contract to Granite Construction Company on April 17th, 1979 for constructing asphaltic concrete pavement, water distribution system complete, sanitary sewers, storm sewers and drainage facilities in the above named Assessment District. At the time of signing the contract, the completion date was scheduled for January 26th, 1980. Since that time, one extension of time has been granted by the Council making the current completion date February 26th, 1980. The work has been completed, however, the assessment must be spread.

RECOMMENDATION

It is recommended therefore, that the Council grant an extension of thirty days to Granite Construction Company by adoption of the attached Resolution Extending Time On Contract.
