REGULAR MEETING

June 10, 2003

The regular meeting of the Sacramento City Council was called to order by Mayor Fargo at 7:09 p.m. on the above date in the Interim City Council Chamber, located at 730 I Street.

CONTINUED FROM AFTERNOON MEETING

5.5A6 On-Street Parking (2 reports)

- A. Proposed On-Street Parking Fees
- B. Proposed Schedule of Parking Penalties

<u>Michael Melvin</u>, Program Specialist, presented staff reports on increasing parking fees and increasing parking penalties.

<u>Bob Thomas</u>, City Manager, explained that the internal auditor is working on a review of on-street parking including meter placement, fees charged, and better use of technology.

<u>Councilmember Hammond</u> stated that she did not believe the reasons for the parking fee increase were sufficient and that she could not support the increase. She did support the

increase in penalties.

<u>Councilmember Tretheway</u> suggested moving toward using GPS rather than traditional ways to enforce parking and the idea of encouraging shopping by making the first hour of parking free.

<u>Councilmember Jones</u> asked for a timeline for code enforcement and raised concerns about commercial vehicles being parked in residential parking.

<u>Councilmember Cohn</u> asked about holiday free parking and the amount of penalties revenue. He confirmed that the increase will go to City funds and not be shared with the State.

Councilmember Tretheway asked for a report back on coordinating holidays for meters with the County.

Mayor Fargo asked for a report back on having meter bags printed with times and on increasing the fees for the daily meter bags.

Report backs were also requested on free weekend parking for downtown museums and businesses; on changing meter times from 8:00-6:00 to 7:00-5:00; and on doubling the parking boot penalty.

A motion was made Councilmember Cohn to approve the parking fee increase, to close the hearing, and to adopt Resolution CC2003-382. The motion was seconded by Councilmember Sheedy. The motion carried with a 7-0-1 vote with Councilmember Waters absent, and Councilmember Hammond abstaining.

A RESOLUTION AMENDING THE CITY OF SACRAMENTO FEE AND CHARGE REPORT ESTABLISHING THE SCHEDULE OF PARKING FEES PURSUANT TOTITLE 10 OF THE SACRAMENTO CITY CODE

A motion was made Councilmember Sheedy and seconded by Councilmember Yee to increase parking penalties, close the hearing, and adopt Resolution CC2003-383. The motion carried with an 8-0 vote with Councilmember Waters absent.

A RESOLUTION AMENDING THE CITY OF SACRAMENTO FEE AND CHARGE REPORT ESTABLISHING THE SCHEDULE OF PARKING PENALTIES AND ADMINISTRATIVE FEES PURSUANT TO TITLE 10 OF THE SACRAMENTO CITY CODE AND THE CALIFORNIA VEHICLE CODE

Reina Schwarts, Budget Manager, presented the report.

<u>Bob Thomas</u>, City Manager, recommended the amount of one million dollars for the deferred maintenance, and one million dollars for enhancing park maintenance.

Report backs were requested for options of growth in TOT taxes, the golf fund, changing from gasoline powered golf carts to electric ones, golf franchise fee, funds for the Oak Park Community Center's Phase II, painting the Guide West Bridge, Sim Community Center expansion, adding lights and playground to the regional dog park, lighting and landscaping funding, using CDBG funds for Fruitridge project.

A motion was made Councilmember Hammond and seconded by Councilmember Sheedy to close the hearing and adopt the intent motion. The motion carried with an 8-0 vote with Councilmember Waters absent.

11.0 PUBLIC HEARINGS

- 11.1 2002 Housing Element Update of the City of Sacramento's General Plan (MOI 097) analyzing existing and projected housing needs, an analysis of potential governmental constraint, residential land inventory, and establishing housing goals, policies, programs and quantified objectives to address the City's housing needs. The Housing Element overs the planning period July 1, 2002 through June 30, 2007 to comply with state law. (D-all)
 - A. Environmental Determination: Addendum to the Previous Adopted Negative Declaration; and
 - B. General Plan Amendment to Section 3 of the City of Sacramento's General Plan

Steve Peterson, Principal Planner, presented the report.

Councilmember Pannell stated that she did not think the community was properly notified.

<u>Councilmember Jones</u> confirmed that the changes are minor, fine tuning. He asked that a program to reach extremely low income residents be added.

Councilmember Sheedy stated she was not ready to support this item until staff did more outreach.

Councilmember Hammond stated that she could not support ministerial approval on group homes, and that special permits should be required.

Councilmember Pannell discussed problems with group homes in her district and suggested changes in the report.

Council discussed the need for better methods of outreach and suggested that the department heads develop plans.

<u>Councilmember Jones</u> reminded the Council that the date for adopting this Housing Element was over one year out of compliance. He agreed that more outreach should have been done but stated that the City will be penalized when applying for grants if this is not passed soon.

Beverly Brown, of the SHRA, reviewed the programs that might be affected by continuing this item.

Council discussed the difficulty in rescheduling the item quickly due to the Council's full calendar and the scheduled 2 week summer break.

Public Testimony:

<u>John Foley</u>, and <u>Ethan Evans</u> of the Sacramento Housing Alliance spoke on the need for additional affordable housing and affordable rental units.

A motion was made Councilmember Jones and seconded by Councilmember Cohn to close the hearing and adopt A) the Staff Recommendation and B) Resolution CC2003-384. The motion carried with an 8-0 vote with Councilmember Waters absent.
