SUBJECT: 1988 Per Capita Grant Reduction and Application Rescheduling

SUMMARY

This report provides information on the reduction in the 1988 Park Bond Act Per Capita grant allocation to the City of Sacramento. In addition, this report requests that City Council, by resolution, approve the rescheduling of several grant projects under the 1988 Park Bond Act Per Capita grant program in order to meet the reduced allocation and to complete the projects in a timely fashion.

BACKGROUND INFORMATION

On December 6, 1988, City Council approved a three year program of grant applications under the 1988 Park Bond Act Per Capita grant program, (Prop 70, California Wildlife, Coastal and Park Land Conservation Act). Applications were made for the six FY 1989-90 projects and have been approved by the State Department of Parks and Recreation.

Recently, the Department of Parks and Community Services was informed that due to a legislative change, the City of Sacramento's allocation under the Per Capita program has been reduced from \$1,010,000 to \$977,000; a reduction of \$33,000. This necessitates a change in the approved program of grant applications. None of the projects could be scaled back by \$33,000 and still remain a worthwhile project. If all project scopes were reduced by an equal amount (approximately \$4,700), thus spreading the reduction evenly across the board, then none of the projects would remain viable.

Included among the FY 1990-91 Per Capita projects was the project for the basic landscaping of Belle Coolegge, a currently undeveloped park site. Approximately three years ago, this park was planned to accommodate a community park and library. Since that time, the site for the library has been shifted, requiring a revised master plan and environmental documents. Because the planning process is taking longer than originally anticipated and to be sure that the grant-funded project can be completed in a timely fashion, staff recommends that the grant application for Belle Coolegge, Phase I be postponed until FY 1991-92. The revised planning process for Belle Coolegge will not be complete until late spring 1990, while applications for the FY 1990-91 round of funding are due September 15, 1989. This postponement of funding is not likely to have a significant effect on the design and construction timeline of the park elements and will certainly not effect the timeline for the library.

The FY 1991-92 projects under the Per Capita grant program include the project for rehabilitation of the Clunie swimming pool filter system. To replace the Belle Coolegge project, staff is recommending that the Clunie pool project be advanced to FY 1990-91.

In summary, in order to meet this reduction in funding staff recommends that:

- 1) That the project for Mangan Range Rehabilitation be eliminated. This choice was made on the basis of the specialized nature of the sport at Mangan Range, community need, and total project cost.;
- 2) That the remaining funds be reassigned to the project for Belle Coolegge, Phase I;
- 3) That the grant application for Belle Coolegge, Phase I be postponed under FY 1991-92; and,
- 4) That the project for rehabilitation of the Clunie swimming pool filter system be advanced to FY 1990-91.

An overview of the proposed changes is provided in Exhibit A.

Revised resolutions are necessary to complete the grant applications for these rescheduled projects.

FINANCIAL DATA

The City of Sacramento had been allocated a total of \$1,010,000 over a three year period under the 1988 Bond Act Per Capita program. Due to a legislative change, the City of Sacramento's allocation has been reduced by \$33,000 to \$977,000. This necessitates elimination of the project for Mangan Range Rehabilitation with remaining funds to go to Belle Coolegge, Phase I.

The rescheduling of Belle Coolegge, Phase I and Clunie Swimming Pool Rehabilitation will not change the total allocation.

No City funds are requested.

POLICY CONSIDERATIONS

No impact.

MBE/WBE EFFORTS

Every effort will be made to support the City's MBE/WBE goals.

RECOMMENDATION

It is recommended that the Budget and Finance Committee approve this report and refer it to the full City Council for action. Further, it is recommended that the City Council, by resolution:

- 1) Eliminate the project for Mangan Range Rehabilitation from the 1988 Park Bond Act Per Capita grant program and reassign the remaining funds to the project for Belle Coolegge, Phase I;
- 2) Postpone the 1988 Bond Act Per Capita grant funded project for Belle Coolegge, Phase I from FY 1990-91 to FY 1991-92; and
- 3) Advance the 1988 Bond Act Per Capita grant funded project for Clunie Swimming Pool Rehabilitation from FY 1991-92 to FY 1990-91.
