SUMMARY

Attached are two resolutions by which you approve for the Redevelopment Agency and the Housing Authority, respectively, the filing of applications for elective coverage of State Disability Insurance (SDI). These resolutions are required by Unemployment Insurance Code §709 for local government agencies to continue SDI coverage for their employees.

BACKGROUND

City of Sacramento employees have disability insurance coverage through Travelers Insurance Company, and the premiums are included in the City contributions for employee health and welfare benefits. Redevelopment Agency and Housing Authority employees are not so covered and, therefore, have for many years had SDI in lieu of private disability insurance. SDI is included in the package of health and welfare benefits listed as employee benefits in the current Memorandum of Understanding with AFSCME Local 146. SDI is optional for government agency employers, but is required for private employers.

A change in State law, new California Unemployment Insurance Code §709, now requires that for local public agencies to continue SDI coverage for their employees, a resolution of the governing body must be adopted.

SDI premiums are employee paid, not employer paid, and cost 1% of annual salary or \$114.00 per year, whichever is less.


