SUBJECT: STORM DRAIN INLET REPLACEMENT PROJECT (PN: WA52) AWARD CONTRACT TO S. W. ALLEN CONSTRUCTION, INC. FOR AN AMOUNT NOT TO EXCEED \$276,900

LOCATION AND COUNCIL DISTRICT:

The Storm Drain Inlet Replacement Project is in Council District 8. See attached location map.

Staff recommends that the City Council accept the bid from S. W. Allen Construction, Inc., for an amount not to exceed \$276,900 and award the contract.

SUMMARY

Bids were received from five contractors and opened by the City Clerk on June 10, 1998. The low bidder was S. W. Allen Construction, Inc., with a bid of \$276,900. S. W. Allen Construction Inc., did not meet the MBE/WBE goals, but their Good Faith Effort documentation has been received. It is therefore proposed to award the contract to S. W. Allen Construction, Inc., for \$276,900.

BACKGROUND INFORMATION

- The project is located in the Airport/Meadowview Community Plan area, the area bounded by Florin Road on the north, 21st Street/15th Street/Henrietta Drive to the east, Meadowview Road to the south, and Freeport Boulevard to the west.
- The project will replace approximately 77 existing drain inlets which will increase storm drain capacity and minimize local flooding due to severe storm events. Additionally, 45 handicap access ramps will be constructed.
- This project is being constructed prior to Public Works asphalt street overlay project within the same project limits.

Bids were received from five contractors, as follows:

• S. W. Allen Construction, Inc.	\$ 276,900
• Navajo Pipelines, Inc.	\$ 312,100
• T & S Construction Company, Inc.	\$ 368,900
• Sierra National Construction, Inc.	\$ 390,400
• Jaeger Construction, Inc	\$ 398,539

The engineer's estimated construction cost was \$280,000. The estimated completion date is September 1998.

FINANCIAL CONSIDERATIONS

The total estimated cost for this project, including all design, construction, inspection and administration is \$310,000. There is sufficient budget in the project (PN: WA52) to award the and complete the project.

ENVIRONMENTAL CONSIDERATIONS

The Office of Environmental Affairs of the Neighborhoods, Planning and Development Services Department has reviewed the proposed project and has determined that this project is exempt from the California Environmental Quality Act (CEQA) under 15301 (b) and 15302 (c) of the CEQA Guidelines.

POLICY CONSIDERATION

This action is consistent with Chapter 58, Article III, Section 58.304 of the City Code concerning award of contracts.

The MBE/WBE participation achieved by all bidders as identified in their bids is listed in the following table:



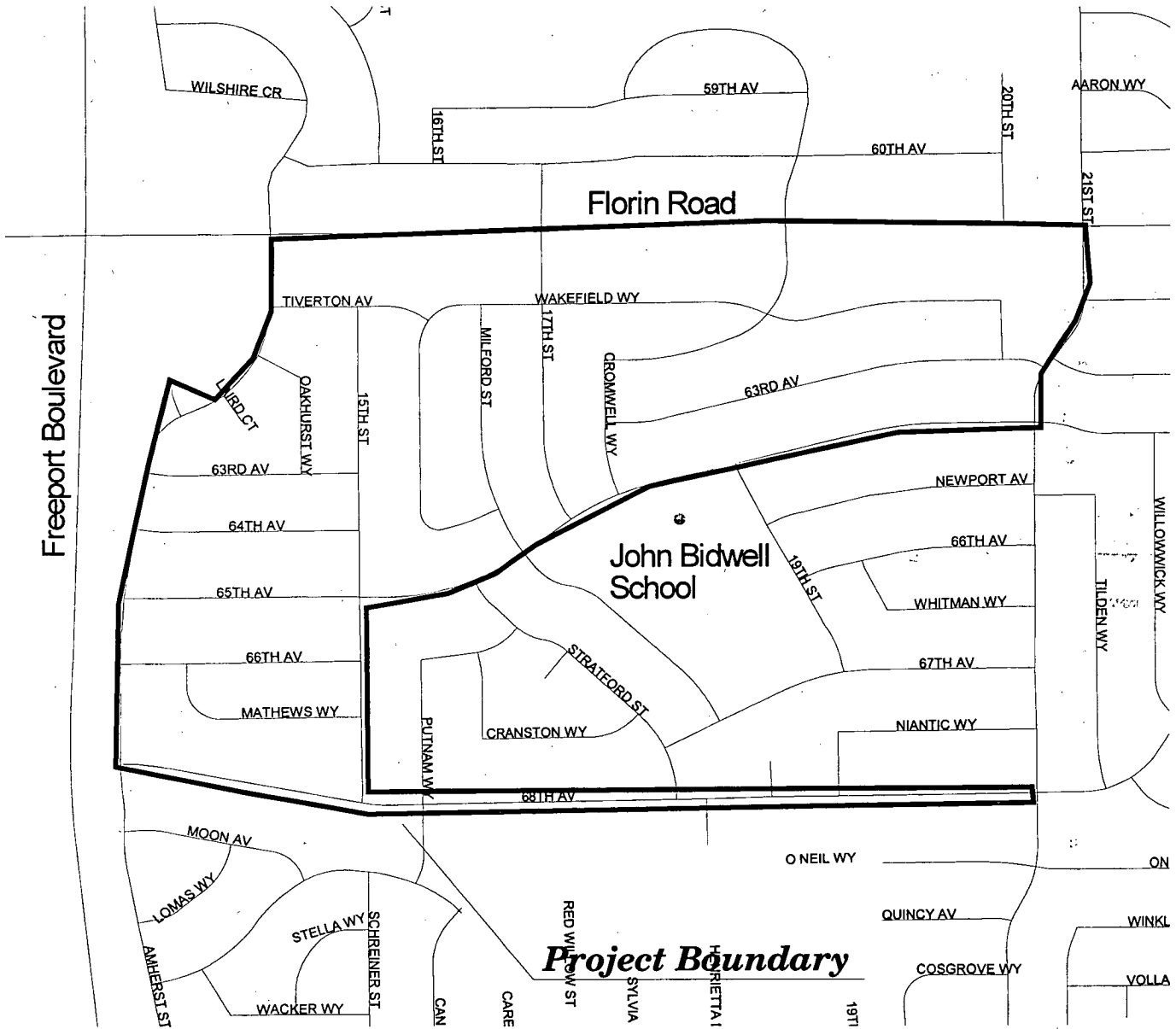

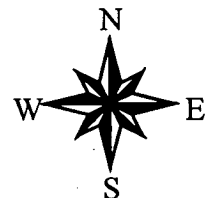

BACKGROUND


The Fire Department operates 23 fire stations throughout the area. Each fire station contains a fire pumper truck which has the ability to bring water and water pressure to fire emergencies. This bid would replace existing fire pumper trucks that are nearly 20 years old, have over 100,000 miles, and have seating for only two firefighters. Funding for these vehicles is from the Fleet Management Fund which accumulated the replacement costs from fleet charges over the life of these vehicles.
