Dear Sir or Madam:

The following issues were brought to my attention for clarification.

1. Since A35 clips have no value to connect eave blocks to wall top plates, this note is an error. As a replacement, provide an LS30 or LS50 clip at each block.
2. The 3rd car garage wall is to be lapped and nailed to the top plate of the main house using standard intersecting wall lapping. Connect using (2) 16d nails per the UBC nailing schedule.

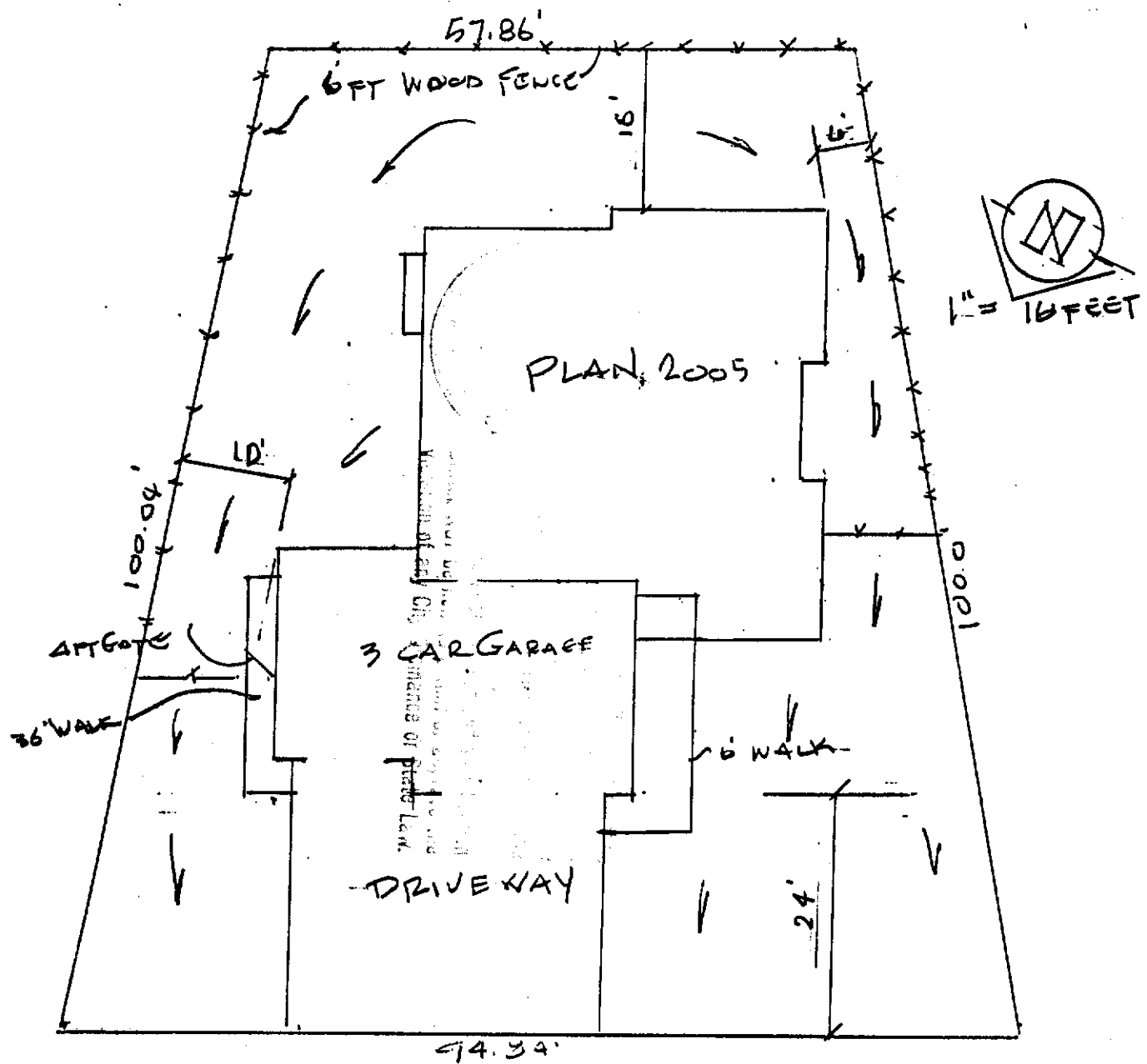
