

ORDINANCE NO. 1189, FOURTH SERIES.

AN ORDINANCE APPROVING ANNEXATION OF UNINHABITED CONTIGUOUS TERRITORY TO THE CITY OF SACRAMENTO TO BE DESIGNATED AS "EASTERN AVENUE TRACT".

WHEREAS, on the 28th day of June, 1946, the Council of the City of Sacramento by resolution duly initiated proceedings for the annexation of certain uninhabited contiguous territory to the City of Sacramento to be designated as "EASTERN AVENUE TRACT", which said uninhabited contiguous territory is hereinafter described; and

WHEREAS, a copy of said resolution was published at least once a week for two successive weeks prior to the hearing of said proceedings in the "SACRAMENTO UNION", a newspaper of general circulation published in the City of Sacramento and the official newspaper of said City of Sacramento; and

WHEREAS, the hour and place for said hearing was set for 8:00 o'clock P.M. July 26, 1946, at the Council Chamber of the City of Sacramento, in the Sacramento City Hall at 9th and Eye Streets, in the City of Sacramento, California; and

WHEREAS, said hearing was duly held at said time, date and place; and

WHEREAS, at said time, date and place no owner of property within the territory proposed to be annexed had filed written or other protest against said proposed annexation; and

WHEREAS, it is to the best interests of the City of Sacramento that said uninhabited contiguous territory be annexed to said City of Sacramento;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

SECTION 1: That that certain uninhabited contiguous territory situated in the County of Sacramento, in the State of California, and more particularly bounded and described as follows, to-wit:

Starting at the point of intersection between the center line of Eastern Avenue and the City Limits of the City of Sacramento southerly along the center line of Eastern Avenue to the point of intersection of the southerly boundary extended of Lot 23 in Eastern Avenue Tract as the same appears on the plat thereof recorded in the office of the County Recorder of the County


of Sacramento; thence easterly along said boundary line to the point of its intersection extended with the westerly boundary of the right-of-way of the Central Pacific Railroad; thence northerly along said boundary line to the point of its intersection with the City Limits of the City of Sacramento; thence along said City Limits to the point of beginning,

be annexed to the City of Sacramento, and said City Council does hereby approve such annexation.


