The State ballot measures are:

- ☐ **Proposition 46** Housing and Emergency Shelter Trust Fund Act of 2002.
- ☐ **Proposition 47** Kindergarten-University Public Education Facilities Bond Act of 2002
- ☐ **Proposition 48** Court Consolidation
- ☐ **Proposition 49** Before and After School Programs, State Grants, Initiative Statute
- ☐ **Proposition 50** Water Quality, Supply and Safe Drinking Water Projects. Coastal Wetlands Purchase and Protection. Bonds Initiative Statutes

- **Proposition 51** Transportation. Distribution of Existing Motor Vehicle Sales and use Tax. Initiative Statute
- **Proposition 52** Election Day Voter Registration. Voter Fraud Penalties. Initiative Statute.

Staff will be providing a staff report with an analysis of each of the seven state ballot measure at the October 15, 2002 Law and Legislation Committee meeting. Included in the upcoming staff report will be a legal analysis provided by the City Attorney's office.
