

Sacramento, California,

November 30, 1932.

The Civil Service Board of the City of Sacramento met in special session on the above date at five-thirty o'clock P. M. in the office of the Board, Room 106 City Hall, President Weisman presiding.

PRESENT: Commissioners Deise and Weisman.
ABSENT : Commissioner Chenu.

It was moved by Commissioner Deise that the reading of the minutes of the previous meetings be dispensed with until a full Board was in attendance. No objection being voiced, it was so ordered.

Communication was received from City Manager Dean, requesting that employment under the classifications of Watchman and Elevator Operator be confined to employees of the City of Sacramento who have become physically incapacitated for the duties which they are performing. Without objection it was laid over until the next meeting. *latter*

Communication was received from City Manager Dean, recommending acceptance of Mrs. Marie A. Goode for permanent employment as Junior Clerk. Without objection it was laid over until the next meeting.

Opinion of Hugh B. Bradford, City Attorney, was received with reference to residence of Greenskeeper for the new Municipal Golf Course. Without objection it was laid over until next meeting.

Request of City Manager Dean for change of classification of Allen Dunlop, an employee of the Recreation Department. Without

objection it was laid over until next meeting.

The next order of business before the Board was the establishment of proper employment dates for members of the Fire Department. This record is for the purpose of pensions. The establishment of these dates is based upon the evidence produced by the Secretary which was secured from the payroll records contained in the Controller's files.

After a review of these records by the members of the Board, and an explanation of the request by Captain Perret and Captain Polkinghorne, the following motion was made. It was properly moved by Commissioner Deise, seconded by Commissioner Weisman, and unanimously carried that the Secretary be instructed to place upon the service record of the employees affected their correct employment date, as evidenced by the records compiled by the Secretary, and that a letter be directed to each employee so affected showing the new employment date and requesting that he acknowledge as correct or else make a complaint to the Civil Service Board stating his date.
