**AMENDING CITY COUNCIL RESOLUTION NO. 94-483, ADOPTED ON
AUGUST 2, 1994, TO ADD ADDITIONAL AREA TO
THE SACRAMENTO ARMY DEPOT REDEVELOPMENT SURVEY AREA AND
AMENDING AND REDESCRIBING THE BOUNDARIES OF THE
SACRAMENTO ARMY DEPOT REDEVELOPMENT SURVEY AREA**

WHEREAS, Section 33310 of the California Community Redevelopment Law (Health and Safety Code Section 33000 et seq., "CRL") provides that a redevelopment survey area may be designated by resolution of the City Council; and

WHEREAS, by Resolution No. 94-483, adopted on August 2, 1994, the City Council designated the Sacramento Army Depot Redevelopment Survey Area and determined that said area required study to determine if a redevelopment project within said area was feasible; and

WHEREAS, the City Council of the City of Sacramento desires that the additional area described below be studied to determine if a redevelopment project within said area is feasible;

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SACRAMENTO:

Section 1. The area shown on the "Map of the Added Area," attached as Exhibit A and incorporated in this resolution by this reference ("Added Area"), is added to the Sacramento Army Depot Redevelopment Survey Area designated by City Council Resolution No. 94-483, adopted on August 2, 1994.

Section 2. The City Council finds and determines that the Added Area requires study to determine if a redevelopment project within said area is feasible.

Section 3. The boundaries of the Sacramento Army Depot Redevelopment Survey Area, as set forth in City Council Resolution No. 94-483, adopted on August 2, 1994, are amended and redescrbed as shown on the "Map of the Amended Sacramento Army Depot Redevelopment Survey Area," attached as Exhibit B and incorporated in this resolution by this reference.

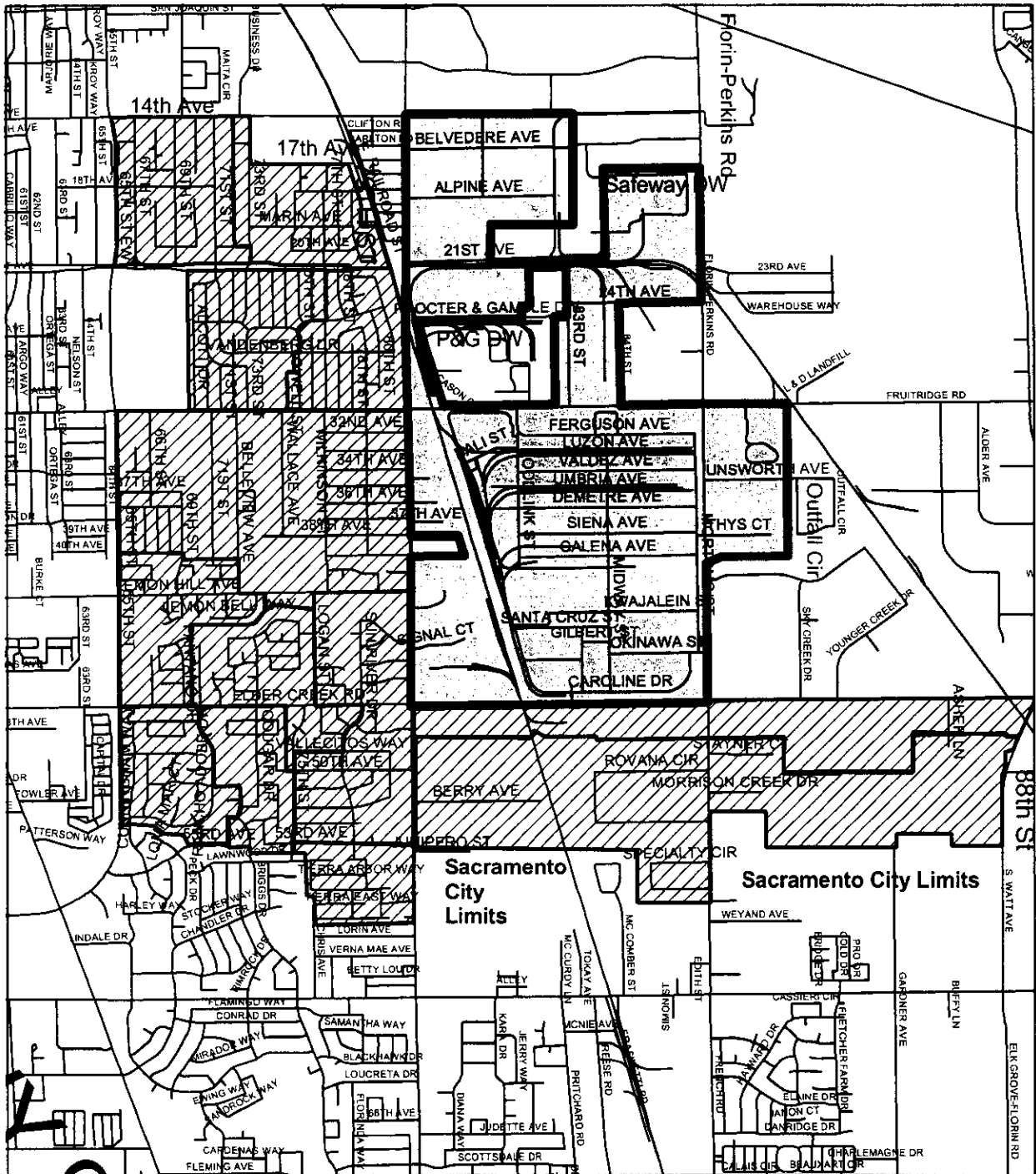


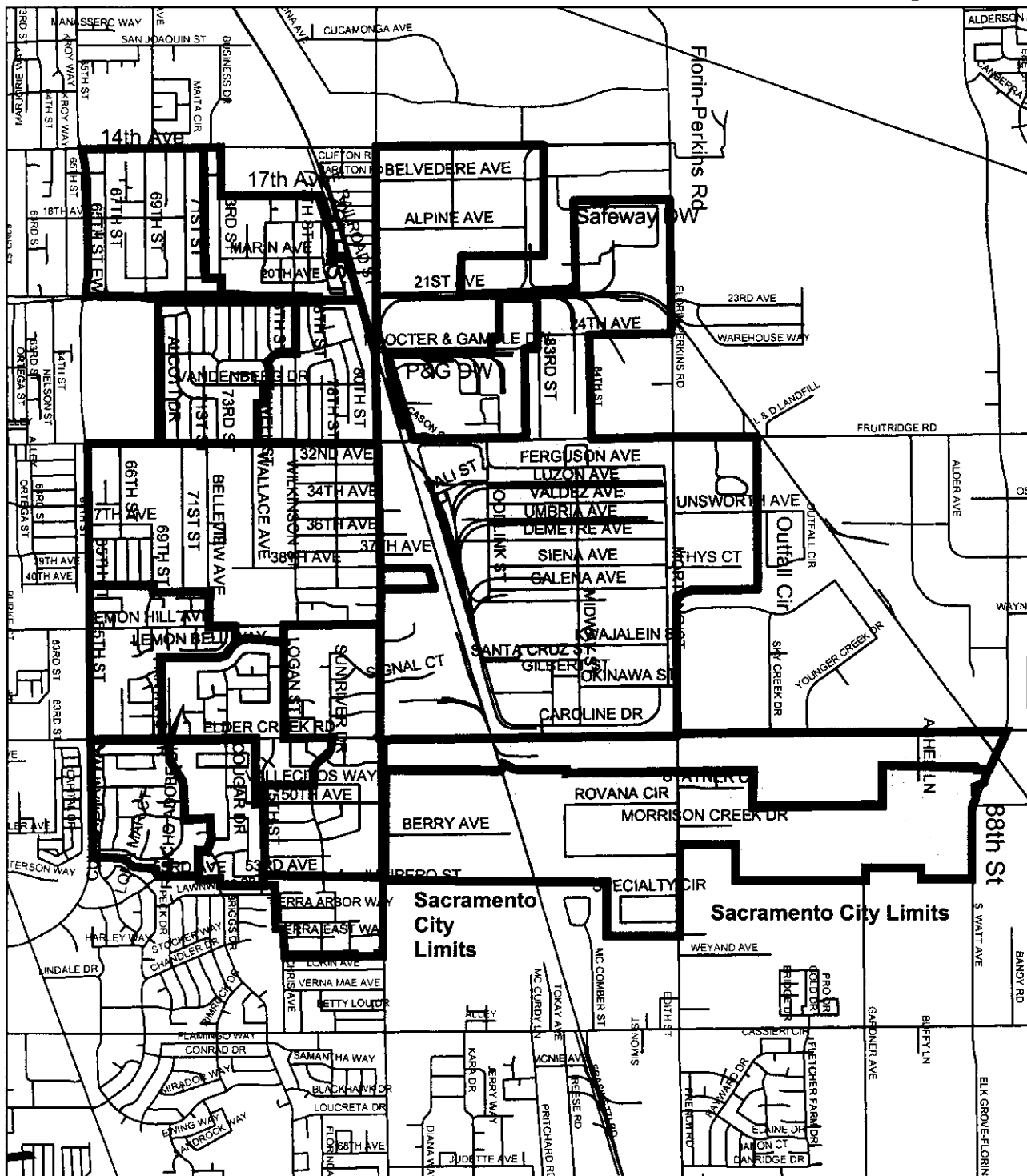
-  Army Depot Redevelopment Area
