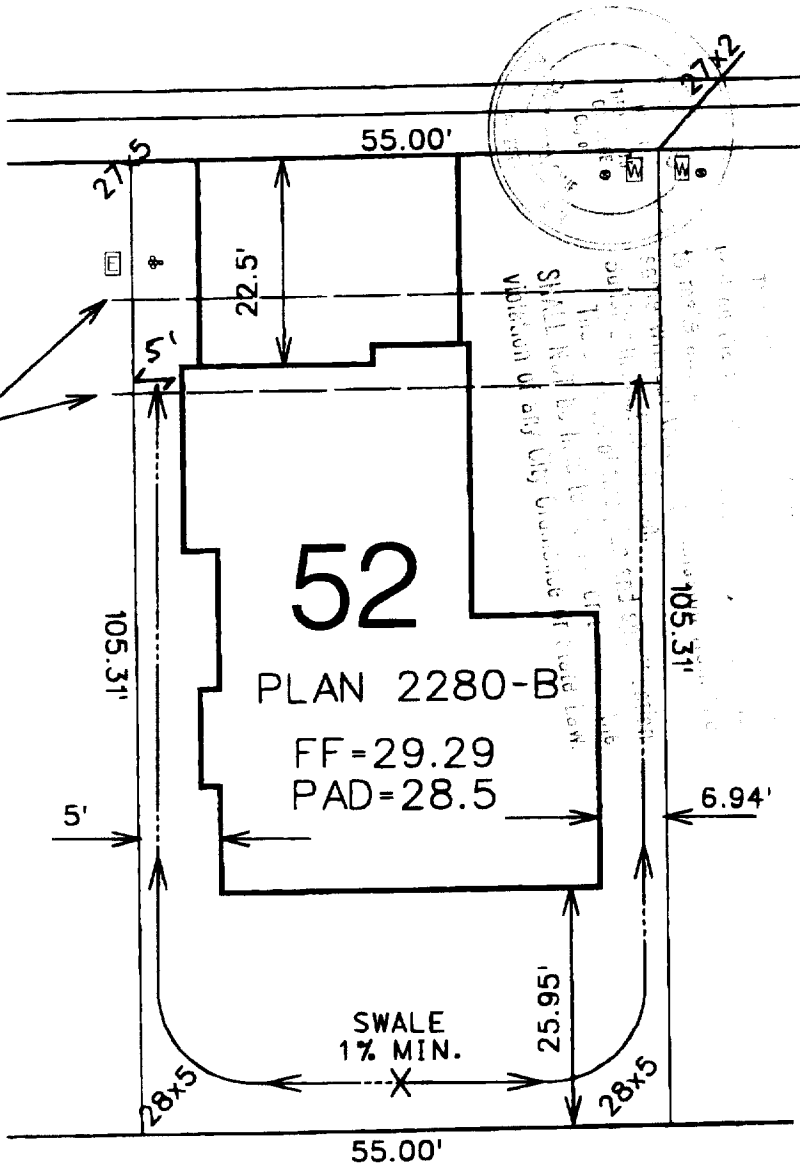

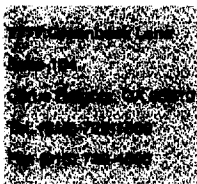

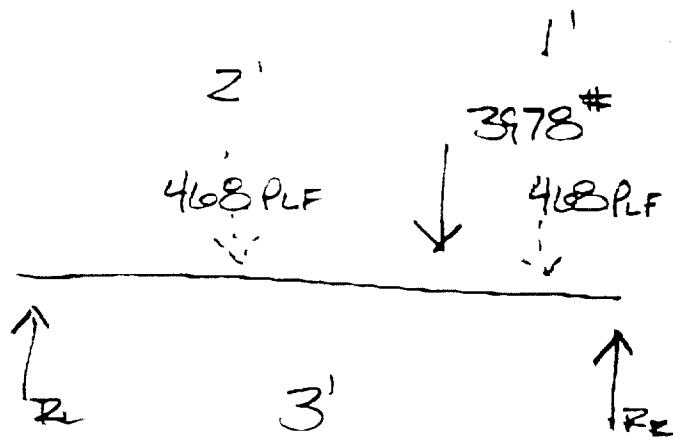
To Whom It May Concern:

This letter is to clarify that the single trimmer on the header located at the kitchen is adequate. The reaction on each end of this beam is 2028# at the left and 3354# at the right. The allowable load at the trimmer is 3281# with a minimum of (2)16d nails transferring load to the king stud. The single trimmer is adequate.
