SUBJECT: Metropolitan Arts Division - Appropriation Increase for California Arts Council Grants

SUMMARY

This report recommends a \$12,700 increase to the FY 1979-80 budget of the Metropolitan Arts Division to reflect funds relating to the receipt of two (2) grants from the California Arts Council.

BACKGROUND

On May 22, 1979 the City Council adopted resolutions authorizing the Sacramento Metropolitan Arts Commission to submit grant applications to the California Arts Council.

The contracts for two (2) grants were received on March 29, 1980. One grant of \$10,000 is to continue a pilot technical assistance program which began in FY 1978-79 emphasizing three areas as follows: (1) a series of workshops, (2) consultants, and (3) a directory. The second grant of \$2,700 is to provide for a graphic designer to design, layout, and prepare camera-ready copy for Arts Commission brochure and other related printed materials.

FINANCIAL DATA

There is no additional cost to the City.



RESOLUTION AMENDING THE CITY BUDGET FOR FY 1979-80
FOR THE DEPARTMENT OF COMMUNITY SERVICES
(METROPOLITAN ARTS DIVISION - CALIFORNIA ARTS COUNCIL GRANTS)

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO:
