

RESOLUTION NO. 2015-0103

Adopted by the Sacramento City Council

April 28, 2015

**RECITING THE FACTS OF THE SPECIAL MUNICIPAL ELECTION HELD ON
APRIL 7, 2015; DECLARING THE RESULTS; AND OTHER SUCH MATTERS
AS PROVIDED BY LAW**

BACKGROUND

- A. A Special Municipal Election was held and conducted in the City of Sacramento, California on Tuesday, April 7, 2015, as required by law.
- B. Notice of the elections were given in the time, form, and manner as provided by law; that voting precincts were properly established; that election officers were appointed and that in all respects the election was held and conducted and the votes were cast, received, and canvassed and the returns made and declared in time, form, and manner as required by the provisions of the Election Code of the State of California.
- C. Pursuant to Resolution Nos. 2014-0402, 2014-0403 and 2014-0404 adopted on December 9, 2014, the Sacramento County Office of Voter Registration and Elections canvassed the returns of the election and has certified the results to this City Council; the results are received, attached and made part hereof as Exhibits A and B.

**BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL
RESOLVES AS FOLLOWS:**

- Section 1. That the whole number of ballots cast in the City was 6,976.
- Section 2. That the names of persons voted for at the election and the votes received for the offices are as follows:

Council District 6

Eric Guerra	4,359
Bruce Pomer	2,556

- Section 3. That the number of votes given at each precinct and the number of votes given in the City to each of the persons above named for the office of City Councilmember in District 6, are as listed in attached Exhibits A and B.

- Section 4. The City Council does declare and determine that Eric Guerra was elected as Councilmember District 6 for the partial term of one year.
- Section 5. The City Clerk shall enter on the records of the City Council of the City a statement of the result of the election showing: 1) the whole number of ballots cast in the City; 2) the names of the persons and measures voted for; 3) for what office and measure each person voted; 4) the number of votes given at each precinct to each person or measure; and 5) the total number of votes given to each person and measure.
- Section 6. That the City Clerk shall on April 28, 2015, make and deliver to the person elected a Certificate of Election signed by the City Clerk and authenticated; that the City Clerk shall also administer to each person elected the Oath of Office prescribed in the Constitution of the State of California and shall have them subscribe to it and file it in the office of the City Clerk. Each and all persons so elected shall then be inducted into the respective office to which they have been elected.
- Section 7. That the City Clerk shall certify the passage and adoption of this resolution and enter it into the book of original resolutions.
- Section 8. Exhibits A and B are part of this resolution.
