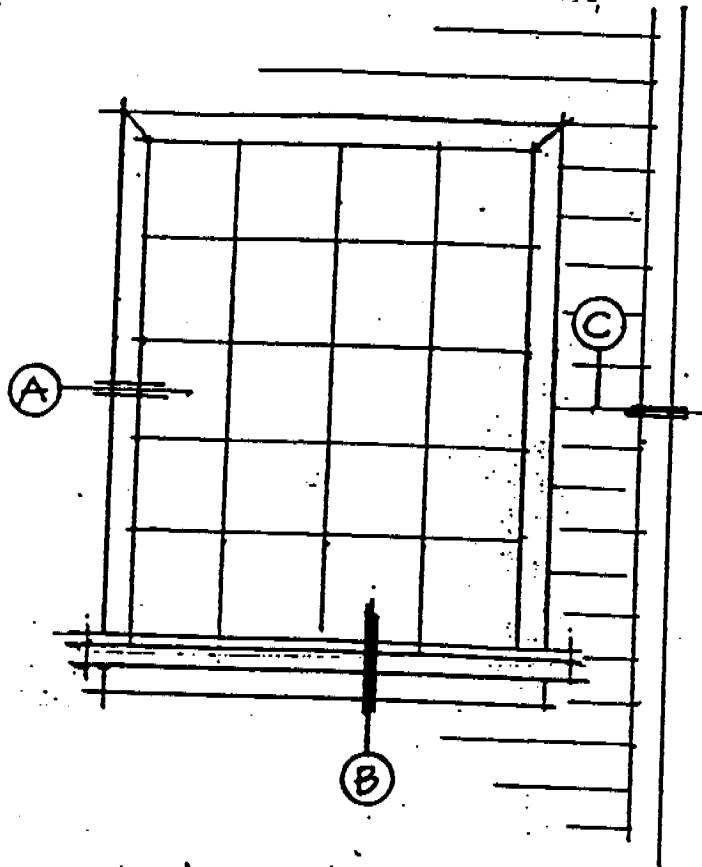

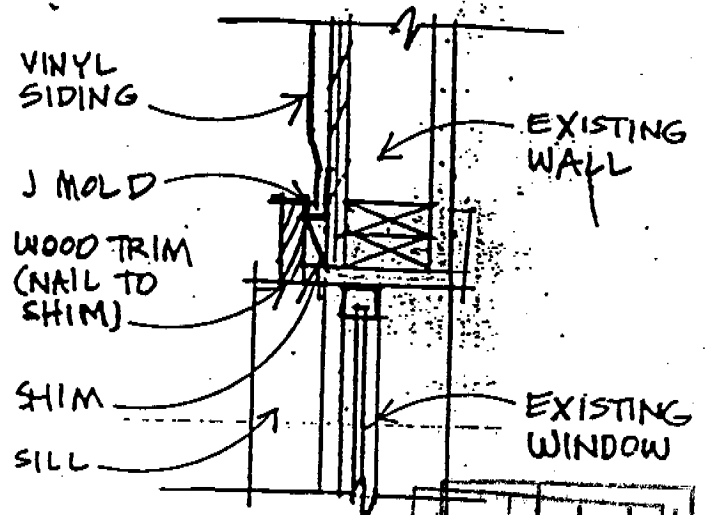

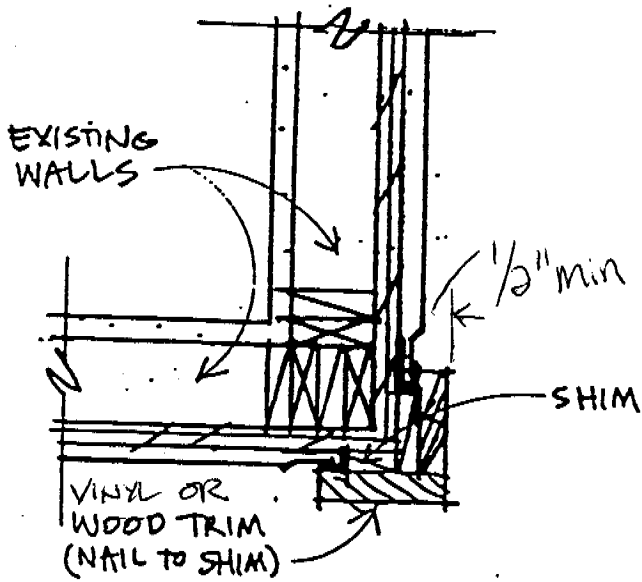


WINDOW ELEVATION

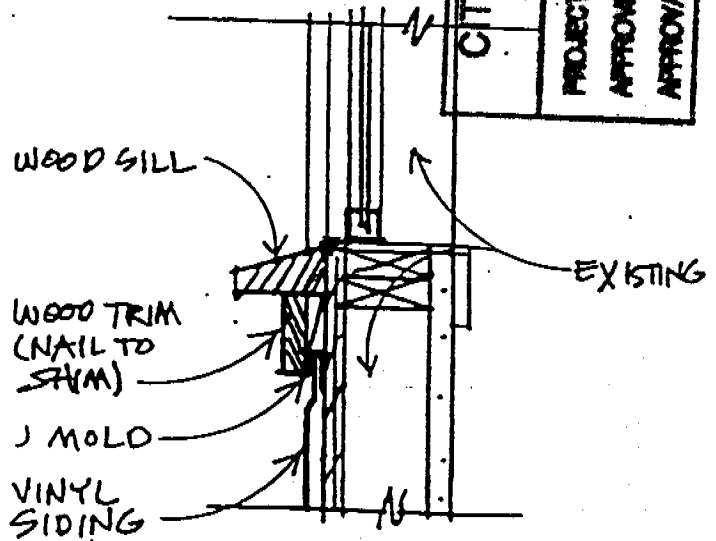
