To date, an effective Council response has been impossible because the Vehicle Code controls all on-street parking regulations. This bill would amend the Vehicle Code and allow local flexibility.

An act to add Section 22507.3 to the Vehicle Code, relating to vehicles.

LEGISLATIVE COUNSEL'S DIGEST

AB 975, as introduced, Karnette. Trailers: parking restrictions.

Existing law authorizes local authorities to adopt by ordinance or resolution provisions prohibiting or restricting the standing or parking of vehicles, which include trailers, on certain streets or highways or portions thereof, in their respective jurisdictions, between the hours of 2 a.m. and 6 a.m. and to prohibit or restrict specified commercial vehicles in a residential district without regard to time.

This bill would specifically authorize local authorities to prohibit or restrict the parking or standing of a trailer that is not attached to a motor vehicle on certain streets or highways without regard to time or district.

Vote: majority. Appropriation: no. Fiscal committee: no. State-mandated local program: no.

*The people of the State of California do enact as follows:*

1 SECTION 1. Section 22507.3 is added to the Vehicle  
2 Code, to read:  
3 22507.3. (a) Notwithstanding 22507.5, local  
4 authorities may, by ordinance or resolution, prohibit or  
5 restrict the parking or standing of a trailer that is not  
6 attached to a motor vehicle on certain streets or  
7 highways, or portions thereof.

1 (b) For the purpose of implementing this section, the  
2 ordinance or resolution shall not be effective unless the  
3 legislative body of the local authority holds a public  
4 hearing on the proposed ordinance or resolution prior to  
5 its adoption, with notice of the public hearing given in  
6 accordance with Section 65090 of the Government Code.
