REPORTS OF DIRECTOR OF PERSONNEL

Reference was made to a letter from Garland Rosauero, Business Representative Local #39, which had been distributed to Board members which addressed an appeal of Kathy Quinn. Mr. Street requested that the record show that this letter was received. Mrs. Donna L. Giles, Director of Personnel addressed the Board and informed them that this would be discussed at a future meeting after staff had had time to prepare a report.

Mr. Jonathan E. Mayhew entered the meeting at 1:39 p.m.

Mrs. Giles informed the Board that in April there are five Tuesdays, which means that they could schedule an extra meeting on the fifth Tuesday at a site in the City, other than the Personnel Department. Motion was made to approve the proposed new classifications of Historian - Architecture and Preservation, and Museum Registrar for the first and second reading.




Motion was approved by unanimous roll call vote.
