SUBJECT: Adopted Resolution Amending Resolution No. 81-051, Granting a Revocable Encroachment Permit to Harold Anderson and Linda Erickson

SUMMARY:

Harold Anderson and Linda Erickson applied for and received a revocable encroachment permit on January 27, 1981 for the purpose of placing brick pavers between the sidewalk and curb at 812 28th Street. An amendment to the revocable encroachment permit waiving "Liability Insurance" is being requested and the City Engineer recommends that the amendment be approved.

BACKGROUND:

Liability Insurance required in Resolution 77-611, October 4, 1977 for revocable encroachment permits, is normally waived in the case of residences. In this case, waiving the Liability Insurance was not included in the original revocable encroachment permit.

RECOMMENDATION:

The City Engineer recommends that the attached amendment to Resolution No. 81-051, adopted January 27, 1981, be passed, adding Special Condition No. 5 - Provision 21 "Liability Insurance" is hereby waived.


Dear Sir and Madam:
