
Dear Sir or Madam:

Where anchor bolts are missing from bottom plates, install 1/2" diameter all-thread embedded minimum 7" into concrete with Simpson Epoxy-Set adhesive. Note: Since anchor bolts are only subjected to a nominal uplift, a pull test is not required for their installation.

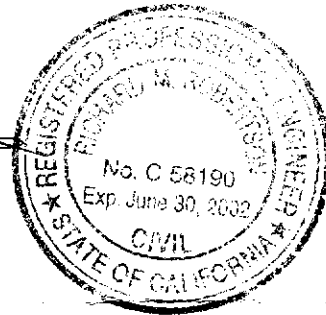
The 3x mud sill may be notched up to 5/8" to allow for recessing of the 2" plate washer.
