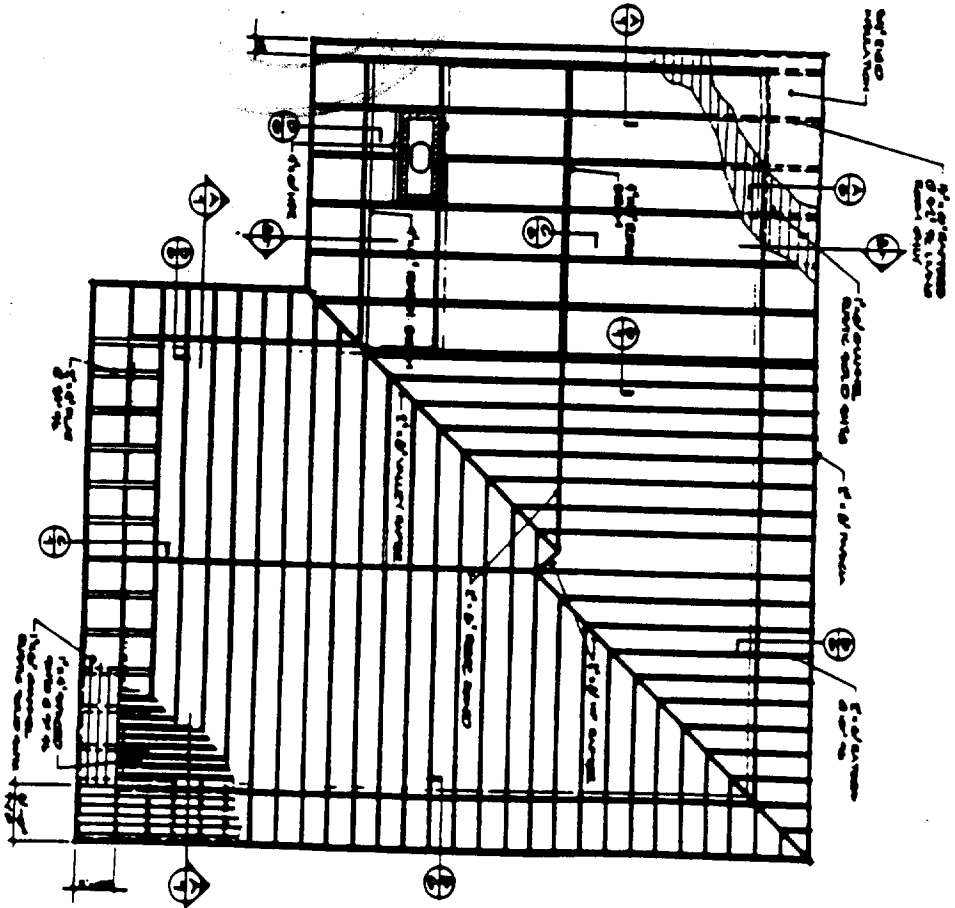
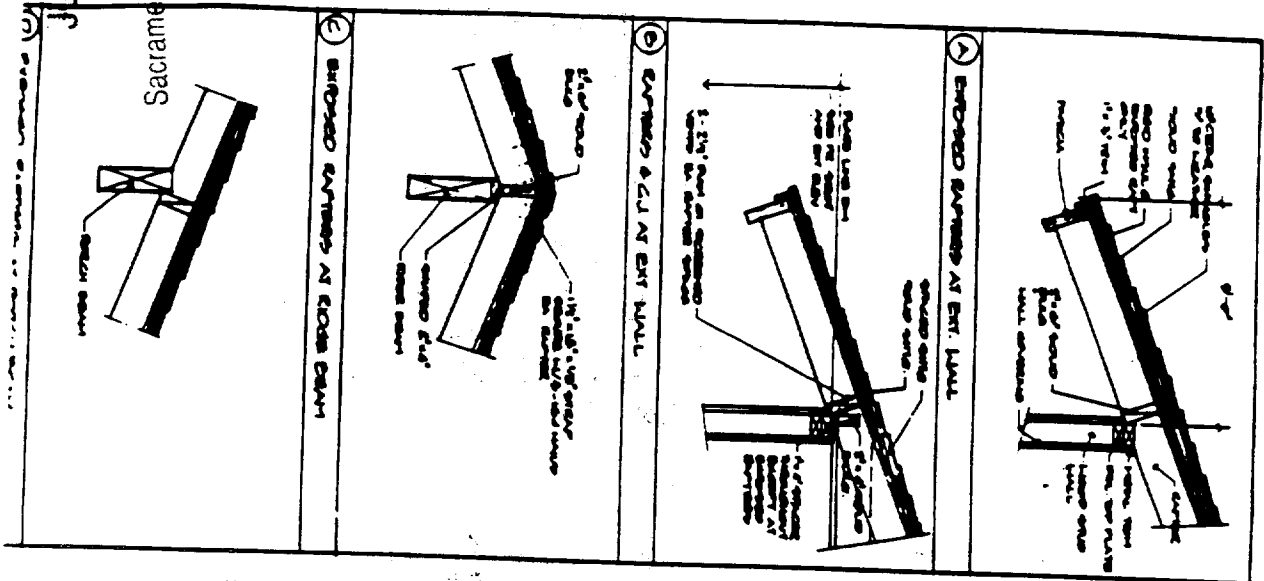

ROOF FRAMING PLAN

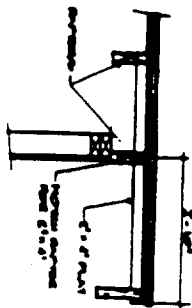
