

Resolved, that the public interest and convenience require, and the City Council of the City of Sacramento hereby orders the following street work to be done, to-wit:

THE IMPROVEMENT OF "D" Street, from the easterly line of 35th Street to the westerly line of 36th Street; Right-of-way, owned by the City of Sacramento, between "C" and "D" Streets, from the easterly line of 35th Street to the center line of 36th Street; Right-of-way, owned by the City of Sacramento, along the rear of lots facing "D" Street on the south, from the easterly line of 35th Street to a point 40 feet westerly from the westerly line of 36th Street; and Right-of-way, owned by the City of Sacramento, between Lots 24 and 25 of "McKinley Terrace" from the northerly line of "D" Street to the northerly line of said lots; that certain street, commonly known as "C" Street, the same being an extension of "C" Street, from the center line of 33d Street to a point 2,250 feet easterly therefrom; and the easterly side of 33d Street, from a point 190 feet north of the north line of "B" Street to a point 10 feet south of the south line of "C" Street;

in the City of Sacramento to the extent, with the materials and in the manner set forth in Resolution of Intention No. 2106, passed and adopted by said City Council on July 1, 1926, reference to which Resolution of Intention is hereby made for a description of said work and improvement, and of the district to be assessed for the costs and expenses of said work.

The City Clerk is hereby directed to post conspicuously for five (5) days on or near the Council Chamber door of the City Council notice hereof, with specifications, inviting sealed proposals or bids for doing said work; and to publish twice a notice hereof, inviting sealed proposals or bids for doing said work; and referring to the specifications posted and on file, the said publication to be in the

Sacramento Union, a daily newspaper published and circulated in said City of Sacramento and hereby designated for that purpose.

All such proposals or bids shall be received by the City Clerk, at his office in the City Hall of said City, on the 12th day of August, 1926, between the hour of 4 o'clock p. m., and the hour of 5 o'clock p. m., and said day is hereby designated as the day on which at the hour of 8 o'clock p. m., the said proposals or bids shall be opened, all of which shall be specified in said notice, and said notice shall require with said proposals or bids a check certified by a responsible bank, payable to the City of Sacramento, for an amount not less than ten per cent (10%) of the aggregate of the proposal, or by a bond for the said amount, and so payable, signed by the bidder and two sureties, all as prescribed by law.
