SUBJECT: Zoo Division - Application for Institute of Museum Services Grant

### SUMMARY

This report recommends the adoption of a resolution authorizing the City Manager to submit a grant application to the Institute of Museum Services to develop a master plan of the Sacramento Zoo.

### BACKGROUND INFORMATION

Presently no adequate master plan of the Sacramento Zoo exists. An extensive site plan is necessary to properly plan future changes at the Zoo. The proposed master plan will investigate our present facilities and programs and set priorities for future development. In addition, there will be an accompanying study on the feasibility of private and corporate support for capital improvements. Visitor and community surveys will be used to determine methods of attracting more visitors and encouraging increased levels of community support. The plan will be developed with community input and presented to the City Council for review and approval.

### FINANCIAL DATA

There will be no direct costs to the City for this program. Expenditures will be reimbursed from revenue associated with the grant. The IMS matching requirement is automatically met by the Zoo Division's operating budget. Funding from the Zoological Society or other private sources will be used to publish the final document.
