DOROTHY DRAKE, LIBRARY
Status

AMENDING VACATION RULE

Communications previously filed with the Board from the Sacramento City Employees' Association, Department

Heads and the City Manager, requesting that Rule 2 of Section 1, relating to vacation allowance in periods of not less than one week, was further considered. After general discussion by members of the Board, Mr. Deise moved that the following amendment to Rule 2 Section 1 "General Provisions Relating to Vacations" be approved for posting for five consecutive days and that hearing be set for five consecutive days and that hearing be set for June 13, 1946 at 7 o'clock P.M. Seconded by Mr. Root, motion carried.

RULE 2 - GENERAL PROVISIONS

Section 1 - Vacation:

After one year of continuous service, each employee of the City of Sacramento is entitled to fifteen days of vacation with pay, excluding time during which he is not regularly assigned to work. For the purpose of computing vacation time, each employee shall be considered to work not more than five days each week.

Upon the approval of the Department Head, employees may take their vacation allowance in periods of not less than one week.

CLERICAL SURVEY

Pursuant to the request of the City Council, Mr. Deise moved that survey of 125 clerical positions in the

City of Sacramento recently completed by the Board, together with detailed letter of transmittal, be approved and the Secretary was ordered to transmit same to the City Council. Seconded by Mr. Root, motion.
