RESOLUTION ACCEPTING RIGHT-OF-WAY DEED

WHEREAS, LOUIS D. CARLSON and ADA H. CARLSON, his wife and JOHN SANDBURG and MINNIE E. SANDBURG, his wife

have made, executed and delivered to the City of Sacramento a certain Right-of-Way Deed, conveying to the City of Sacramento the following real property in the City of Sacramento, County of Sacramento, State of California, bounded and particularly described as follows:

Beginning at a point from which the most northerly corner of Lot 170, as said Lot is shown and so designated on the official Plat of Orchard Terrace Unit No. 2, filed March 18, 1948, in the office of the Recorder of Sacramento County and recorded in Book 27 of Maps, Map No. 37, bears North 67° 41' East 141.00 feet and thence South 22° 19' East 30.00 feet; thence from said point of beginning North 22° 19' West 50.89 feet; thence curving to the left on an arc of 1216.40 feet radius, said arc being subtended by a chord bearing North 36° 55' 15" West 613.41 feet; thence North 51° 31' 30" West 576.00 feet; thence curving to the right on an arc of 2755.00 feet radius, said arc being subtended by a chord bearing North 46° 30' West 482.70 feet; thence curving to the left on an arc of 190.00 feet radius, said arc being subtended by a chord bearing North 30° 40' 55" East 168.46 feet; thence curving to the left on an arc of 379.00 feet radius, said arc being subtended by a chord bearing North 15° 17' 30" West 255.00 feet; thence curving to the right on an arc of 1144.00 feet radius, said arc being subtended by a chord bearing North 15° 48' 50" West 750.04 feet; thence curving to the right on an arc of 525.00 feet radius, said arc being subtended by a chord bearing North 22° 37' 10" East 346.99 feet; and thence North 41° 55' East 21.00 feet to a point on the center line of a Right-of-Way described in a deed executed by Louis D. Carlson, et al, to City of Sacramento, Dated November 1, 1946 and recorded in the office of the Recorder of Sacramento County on December 2, 1946 in Book 1306 of Official Records at page 92.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SACRAMENTO:

That the said Right-of-Way Deed be, and the same is, hereby accepted; the City Clerk being directed to attach certified copy hereof to the said Right-of-Way Deed, and record same in the office of the Sacramento County Recorder.
