SUBJECT: REQUEST FOR GRANT APPLICATION APPROVAL - INNOVATIVE NEIGHBORHOOD
ORIENTED POLICING PROGRAM

SUMMARY

The Police Department is requesting formal approval to apply to the U.S. Department of Justice for a \$200,000 "Innovative Neighborhood Oriented Policing Program" grant. This grant will be funded 100% by the U.S. Department of Justice with no cash match required by the City of Sacramento.

It is recommended that Budget and Finance Committee approve this grant application and forward this report to the full City Council.

BACKGROUND

The U.S. Department of Justice, Bureau of Justice Assistance, is offering Federal assistance under the Anti-Drug Abuse Act of 1988 to state and local criminal justice agencies to test, evaluate and document new programs to encourage community involvement in drug and crime control activities. The Police Department is requesting formal approval to submit a grant request to establish an "Innovative Neighborhood Oriented Policing" program as part of the Department's new "Problem Oriented Policing" strategy.

The Innovative Neighborhood Oriented Policing program is designed to develop and demonstrate innovative community policing programs which target demand reduction at the neighborhood level. This program involves the "co-production of public safety" through extensive partnership efforts among law enforcement, other local government agencies, business, schools, community/social organizations, and citizens.

The Innovative Neighborhood Oriented Policing program is based on the premise that crime and drug problems must be addressed by the entire community, not just the Police Department. Therefore, this program is designed for the Police Department to bring together various representatives from the groups mentioned above to form cooperative demand reduction plans and strategies.

Formal approval to apply for this grant is consistent with past practices.




RECOMMENDATION
