SUBJECT: Revocable Encroachment Permit - State of California -  
Department of General Services

SUMMARY:

The State of California - Department of General Services has applied for a revocable encroachment permit for the purpose of constructing colored and patterned sidewalk paving. The City Engineer recommends that the permit be granted.

BACKGROUND:

The area for which this request is being made consists of an area adjacent to Permittee's property. The 16' wide sidewalk area surrounding the block bounded by 7th and 8th, "N" and "O" Streets (County Assessor's Parcel 6-203-12) and the 16' wide sidewalk area adjacent to the south 1/2 of the block bounded by 7th and 8th and "N" Streets and Capitol Mall (a portion of County Assessor's Parcel 6-154-1).

RECOMMENDATION:

The City Engineer recommends that the attached resolution be passed granting a revocable encroachment permit to the State of California - Department of General Services in the area and for the purpose outlined above.

# RESOLUTION NO. 81-433

RESOLUTION GRANTING REVOCABLE ENCROACHMENT TO:

State of California - Dept. of General Services

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

That a revocable encroachment permit for the purpose of

Constructing colored and patterned sidewalk paving

is hereby granted to State of California - Dept of General Services

whose address is as follows: 915 Capitol Mall, Suite 590, Sac, CA 95814.

The encroachment area is described as follows:

An area adjacent to Permittee's property. The 16' wide sidewalk area surrounding the block bounded by 7th and 8th, "N" and "O" Streets (County Assessor's Parcel 6-203-12) and the 16' wide sidewalk area adjacent to the south 1/2 of the block bounded by 7th and 8th and "N" Streets and Capitol Mall (a portion of County Assessor's Parcel 6-154-1).

This permit is granted subject to the "General Provisions - Revocable Encroachment Permit", which were adopted by the City Council in Resolution No. 77-611 dated October 4, 1977, and the hereinafter specified special conditions, if any. This permit shall be effective only after the applicant files with the Department of Finance of the City of Sacramento, the insurance certificates required by the General Provisions.

## SPECIAL CONDITIONS

1. Permittee shall comply with all the requirements of the City Planning Department, Building Inspections Division, and Community Services Dept.
2. Permittee shall conform with requirements of Street Maintenance Division. Before placing sidewalks, notify Bill Seeber at 449-5236.
