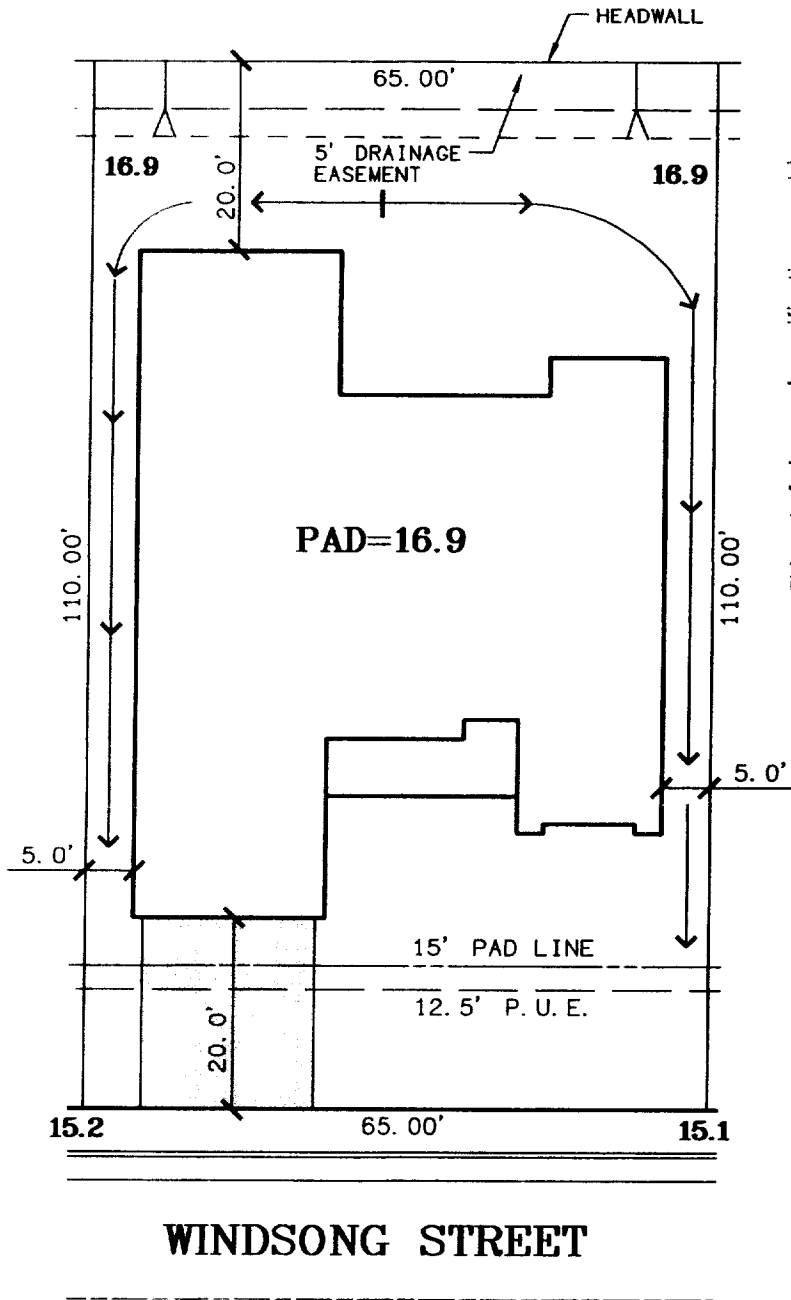

Dear Building Department,

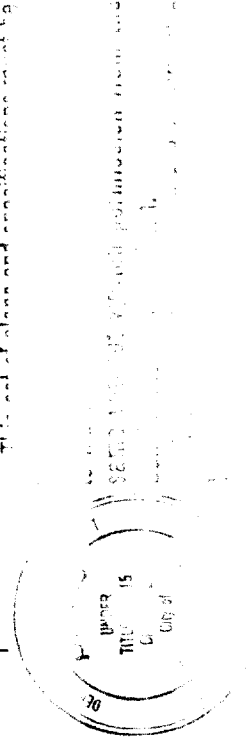
