When approval is granted by the Public Works Department, Beck Properties, Inc. will construct said retaining wall and fence as soon as possible.

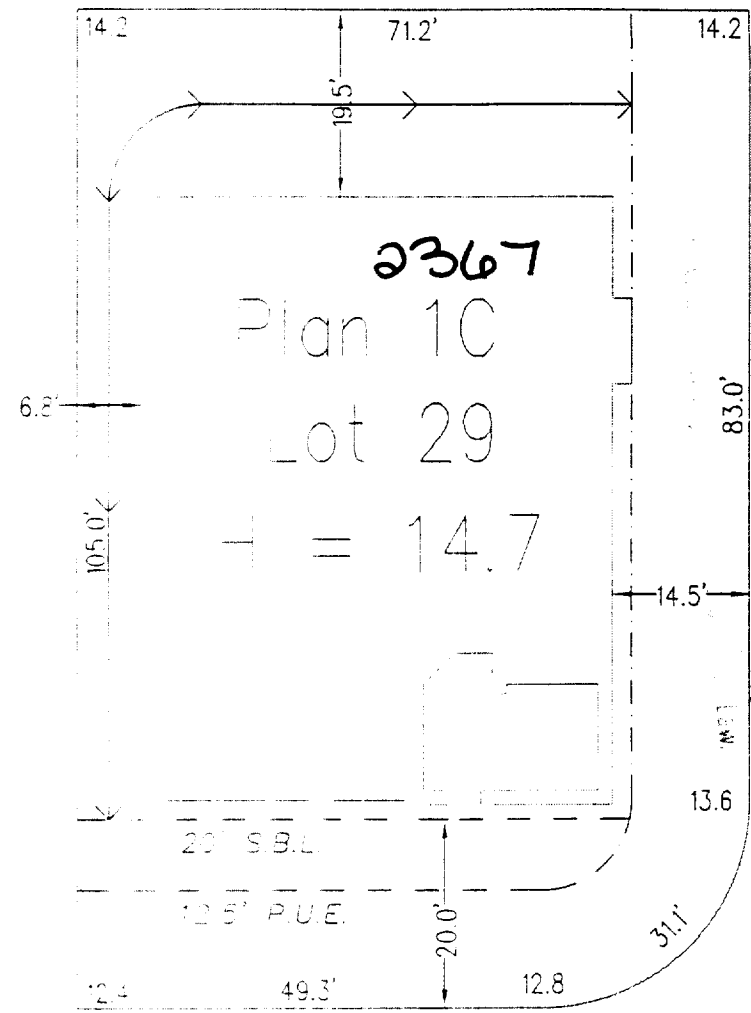
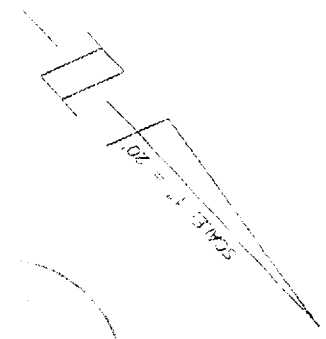
