SUBJECT: Energy Planner Position

SUMMARY

The City Council, on December 16, 1980, approved seven energy measures and a new planner position to implement those adopted measures. The Budget and Finance Committee approved the position on November 18, 1980.

The Planning Department would like to fill this position in the current fiscal year. Consequently, the department's budget must be amended to provide funding for the position. At this time, the Planning Department anticipates this position to be at the Associate Planner level. Funding for this position will be from the Administrative Contingency Fund to the Planning Department budget for the remainder of Fiscal Year 1980-81.

RECOMMENDATION

The staff recommends that the City Council approve the transfer of \$9,192 from the Administrative Contingency Fund #101-5070-0000-4399 to the Planning Department budget #101-2300-0000-4101 for the remainder of Fiscal Year 1980-81 for the new planner position by adopting the attached resolution.
