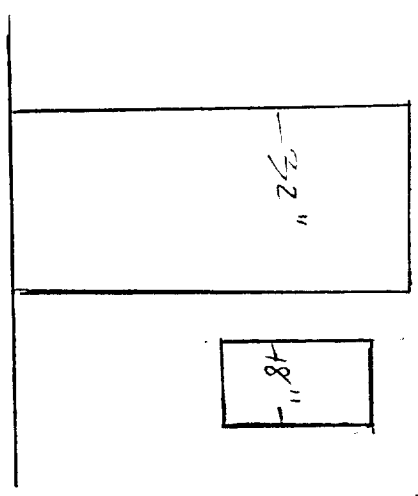

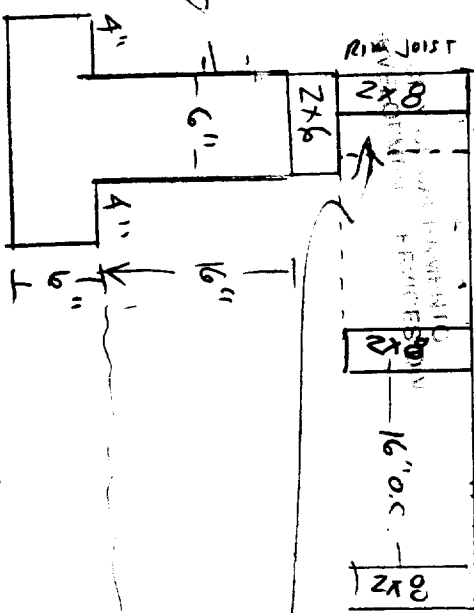

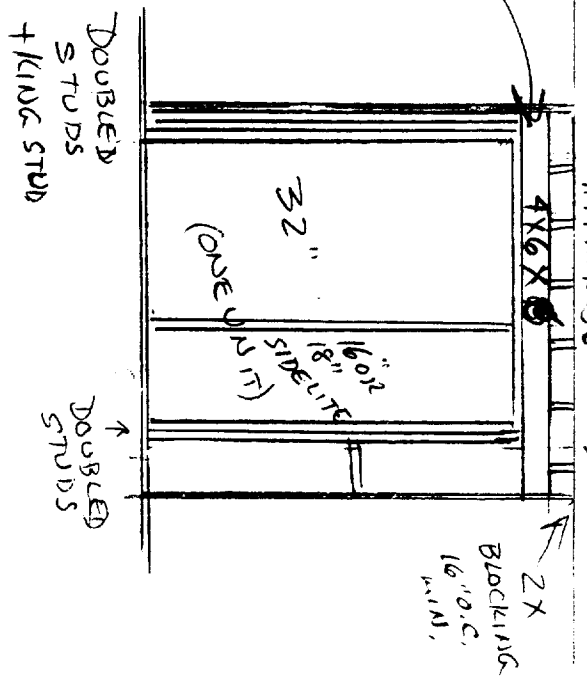


EXISTING FOUNDATION
