

ORDINANCE NO. 1042, FOURTH SERIES

AN ORDINANCE AMENDING ORDINANCE NO. 669, FOURTH SERIES, PASSED JUNE 27, 1935, AND ENTITLED: "AN ORDINANCE PROVIDING FOR THE LICENSING AND REGULATION OF DANCING IN PLACES WHERE LIQUORS ARE SOLD; PROVIDING A PENALTY FOR THE VIOLATION OF THIS ORDINANCE; REPEALING SECTION 4 OF ORDINANCE NO. 317, THIRD SERIES, PASSED OCTOBER 11, 1917, AND MAKING THIS ORDINANCE AN EMERGENCY MEASURE TO TAKE EFFECT IMMEDIATELY", BY ADDING SUBDIVISIONS 3 AND 4 TO SECTION 3 OF SAID ORDINANCE, AND REPEALING ORDINANCE NO. 1028, FOURTH SERIES, PASSED NOVEMBER 20, 1944.

BE IT ENACTED BY THE COUNCIL OF THE CITY OF  
SACRAMENTO:

SECTION 1: Ordinance No. 669, Fourth Series, passed June 27, 1935, is hereby amended by adding Subdivision 3 to Section 3 of said Ordinance:

Subdivision 3: The area bounded as follows: Commencing at a point on the center line of 3rd Street 665½ feet south of the center line of Broadway; thence in an easterly direction parallel to the center line of Broadway to the west boundary line of the property occupied by the New Helvetia Housing Project; thence northerly along the west boundary of the New Helvetia Housing Project to the point of intersection of the center line of Broadway with the west boundary line of the New Helvetia Project extended; thence in an easterly direction to the intersection of the center lines of Broadway and 9th Streets; thence to a point on the center line of 9th Street 200 feet north of the intersection of the center line of Broadway with the center line of 9th Street; thence in a westerly direction parallel to the center line of Broadway to the center line of 3rd Street; thence along the center line of 3rd Street to the point of beginning.

SECTION 2: Ordinance No. 669, Fourth Series, passed June 27, 1935, is hereby amended by adding Subdivision 4 to Section 3 of said Ordinance:

Subdivision 4: The area bounded as follows: Commencing at the intersection of the center lines of 12th Street and the Southern Pacific Right-of-way on the "B" Street Levee; thence in a southerly di-

direction on the center line of 12th Street to the intersection of the center line of the alley between "D" and "E" Streets with the center line of 12th Street; thence in an easterly direction to the intersection of the center line of the alley between "D" and "E" Streets with the center line of 16th Street; thence in a northerly direction to the intersection of the center line of 16th Street with the center line of the Southern Pacific Right-of-Way on the "B" Street Levee; thence in a westerly direction to the point of beginning.


SECTION 3: Ordinance No. 1028, passed November 20, 1944, is hereby repealed.

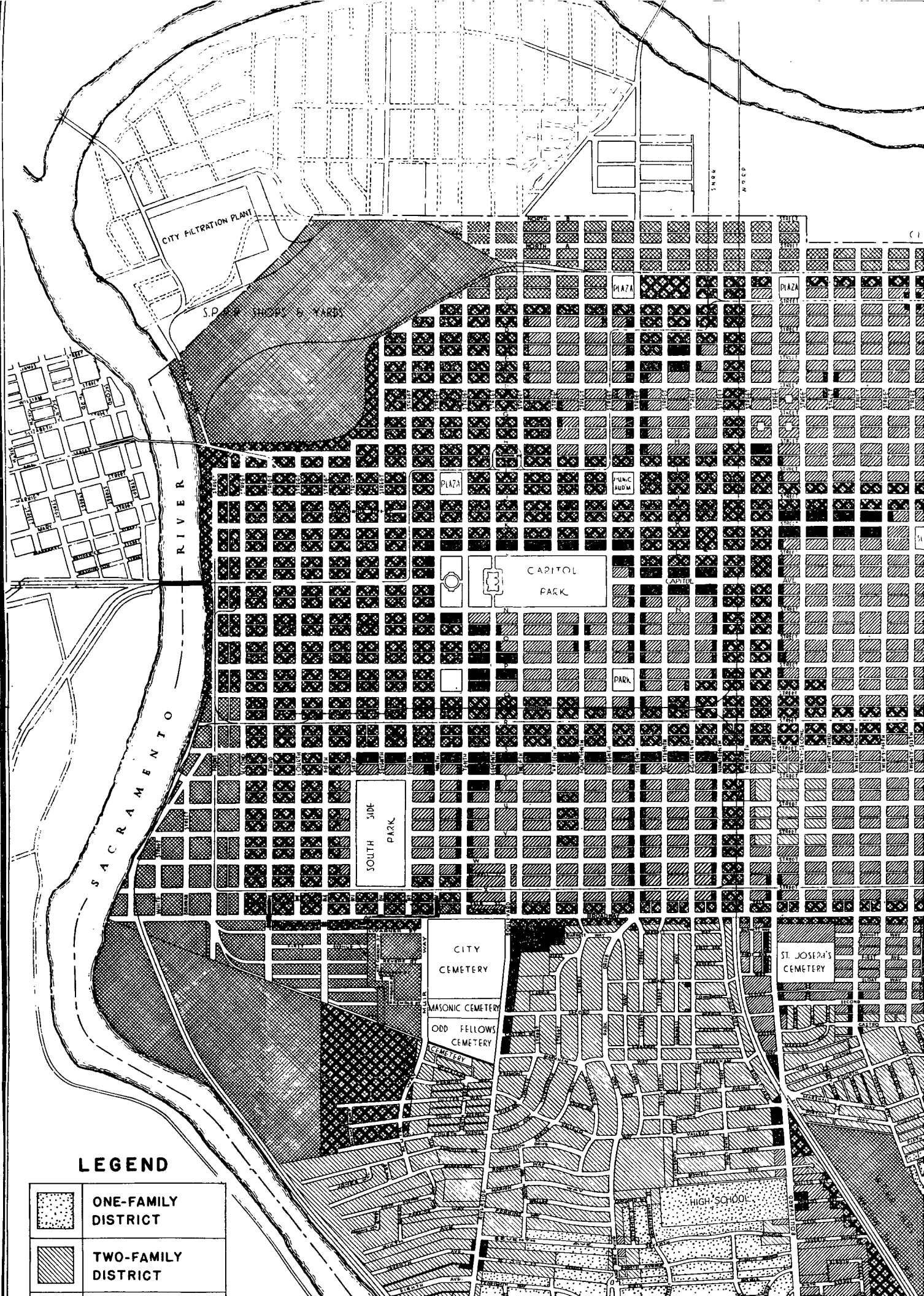
