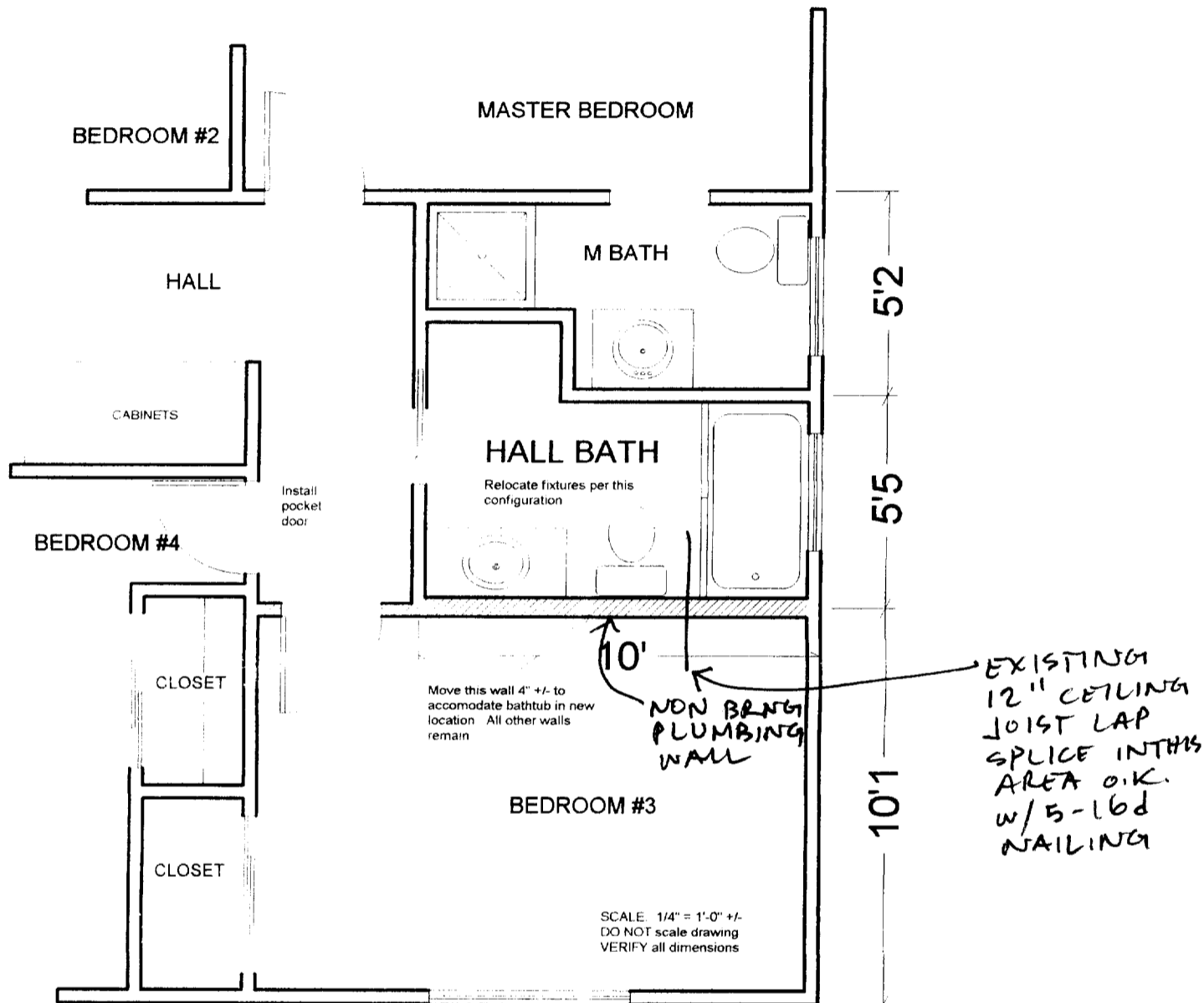

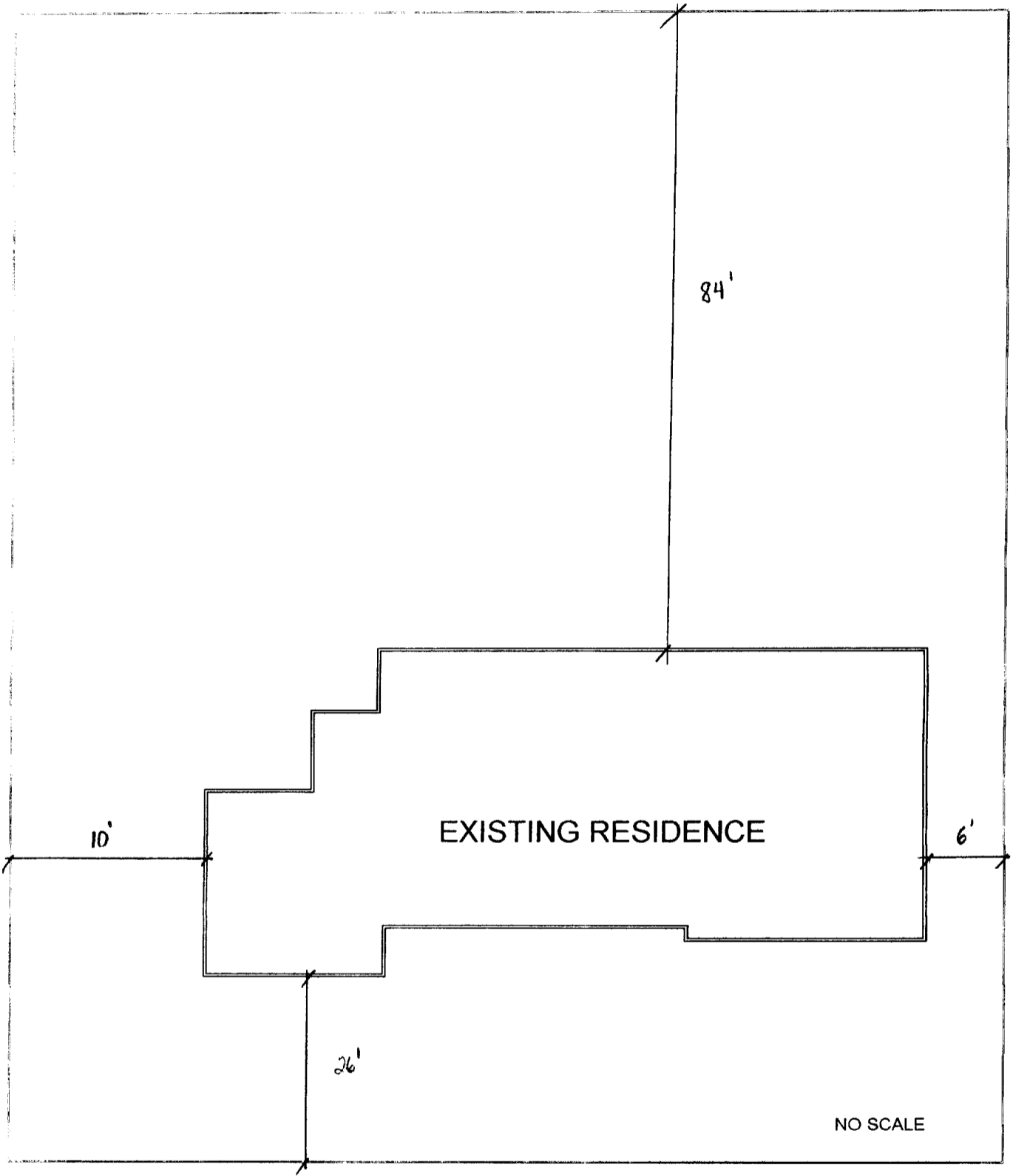

NEW HALL BATH PLAN

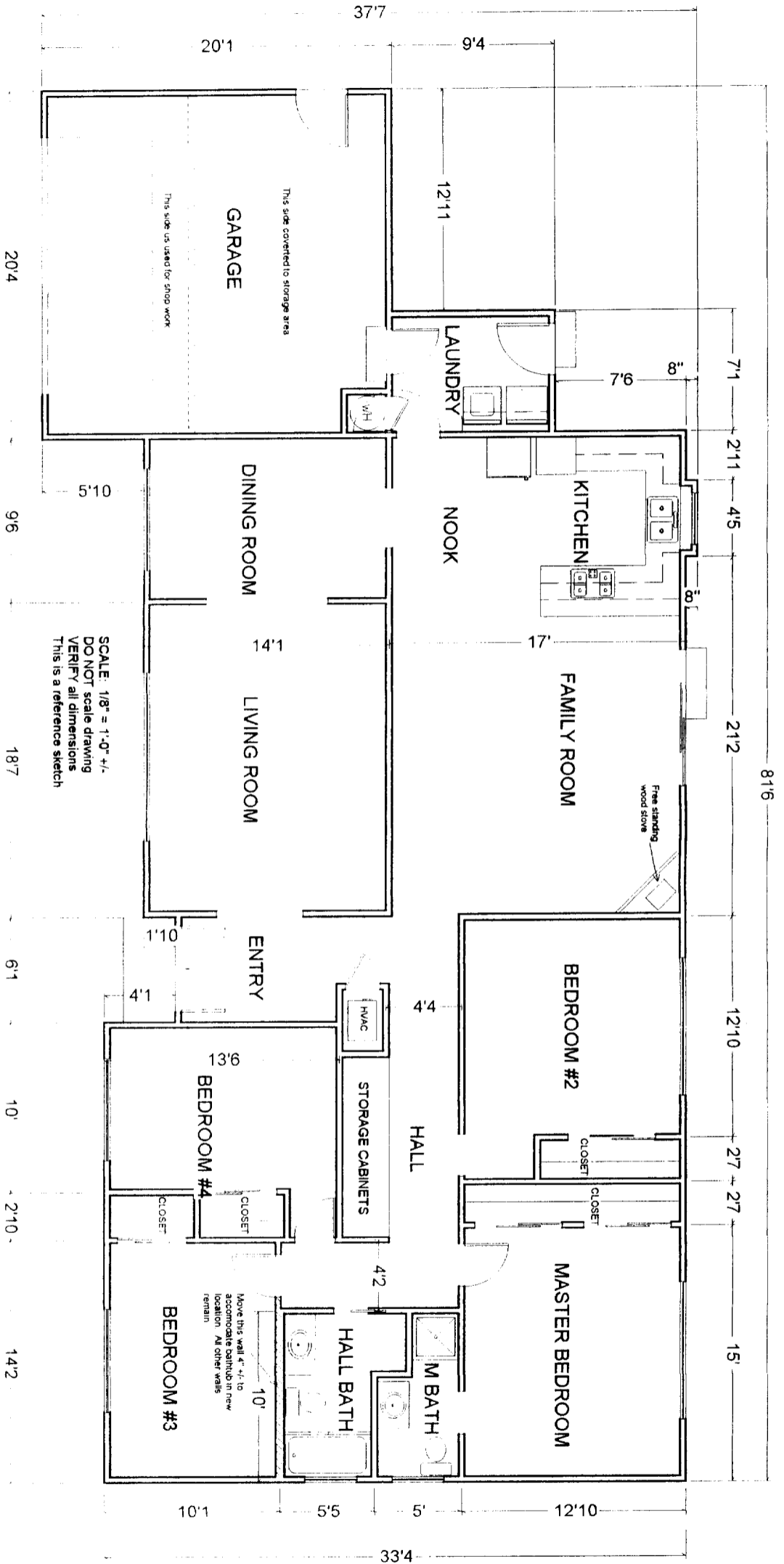

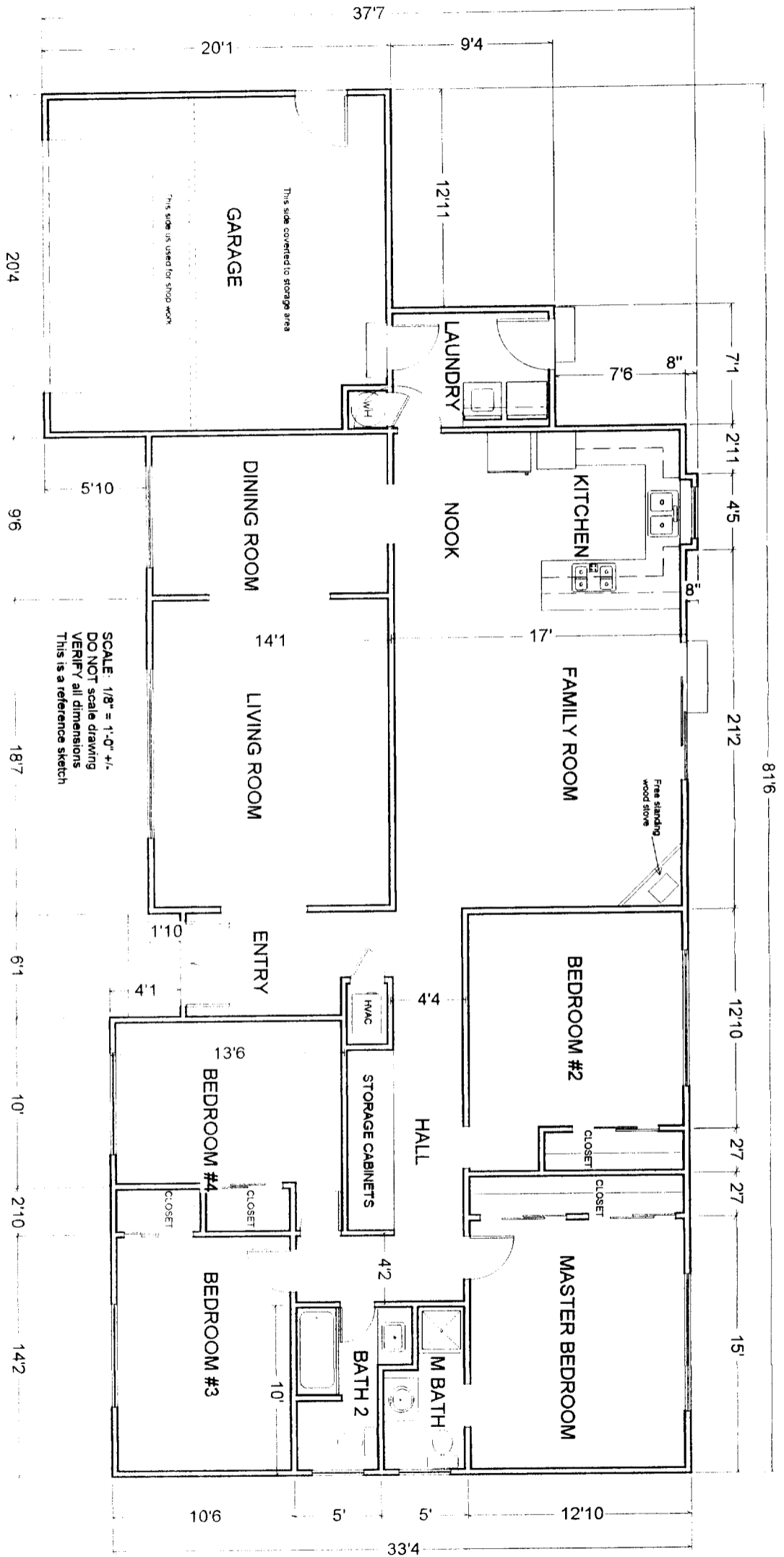
PLOT PLAN
