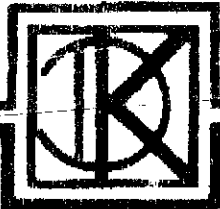

The framing inspection for the house located at 3969 57th Street in Sacramento was not performed as required by Code due to the installation of lapped siding over the shear panels. The solution I am recommending for this situation is to have the Owner re-do the sheathing installation on the interior side of the wall. This installation of sheathing will comply with all the requirements set forth for exterior sheathing installation. The sheathing shall be 3/8" CDX plywood with 8d nails at 6" O.C. along edges and 8" O.C. in the field. The inside sheathing will more than compensate for the exterior sheathing.
