SUBJECT: MAJOR URBAN RESOURCE LIBRARY (MURL) AWARD,  
BUDGET AUGMENTATION OF \$2,907.

SUMMARY

The Library requests Budget & Finance recommend approval of an increase in appropriation authority for the MURL Award in the amount of \$2,907.

BACKGROUND

The Library, in estimating Grant revenue for the MURL award, budgeted \$23,723 as MURL grant revenue for the 1989-90 budget year. Actual revenue dollars would not be known until after the 1989-90 budget cycle was complete. The Library has since received notification that the actual MURL grant award is \$26,630. This is \$2,907 above the budgeted level.

MURL grant dollars are to be used for the specific purposes which are outlined in the grant application and may not be used to supplement other funds. In this program year the Library will use MURL dollars to improve its regional Business collection.

FINANCIAL IMPACT

Increase in grant appropriation has no impact on general fund. The additional dollars increases the purchasing limits of the MURL program.

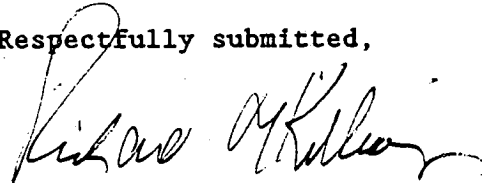

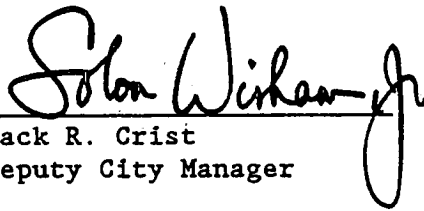
