SUBJECT: UNDULATIONS 1992/1993 (JN:2993/PN:SH36) - CONTRACT AWARD

SUMMARY

This project has been advertised for bids. Bids have been received and contract award is recommended.

STAFF RECOMMENDATION

It is recommended that the City Council accept the low bid of Stan Gilbert Construction, Inc. in the amount of \$21,518.00, and award the contract.

BACKGROUND INFORMATION

This project is a continuation of the program to install undulations on residential City streets where there has been a history of excessive vehicle speed.

On August 25, 1992, the City Council approved the plans and specifications for this project. Bids were received and opened by the City Clerk on September 23, 1992. The bids received were:

Stan Gilbert Construction, Inc.	\$21,518.00
Western Eng. Contractors	\$22,260.00
Granite Construction Company	\$22,260.00
R. C. Collet, Inc.	\$23,375.00
Biondi Paving, Inc.	\$24,975.00

The engineer's estimated construction cost was \$23,800.00. The estimated project completion date is November 30, 1992.

FINANCIAL CONSIDERATIONS

The current estimated total project cost, including all planning, design, construction, and signing and striping costs, is \$59,000.00. The current budget is \$63,000, which was approved in the Capital Improvement Program from Gas Tax (202). The funds available for this project amount to \$52,453.00, as of October 2, 1992.


POLICY CONSIDERATIONS

This action is consistent with Chapter 58, Article III, Section 58.304 of the City Code concerning award of contracts.


MBE/WBE



All five planholders submitted bids for the project, however, the low bid was not submitted by the MBE planholder.

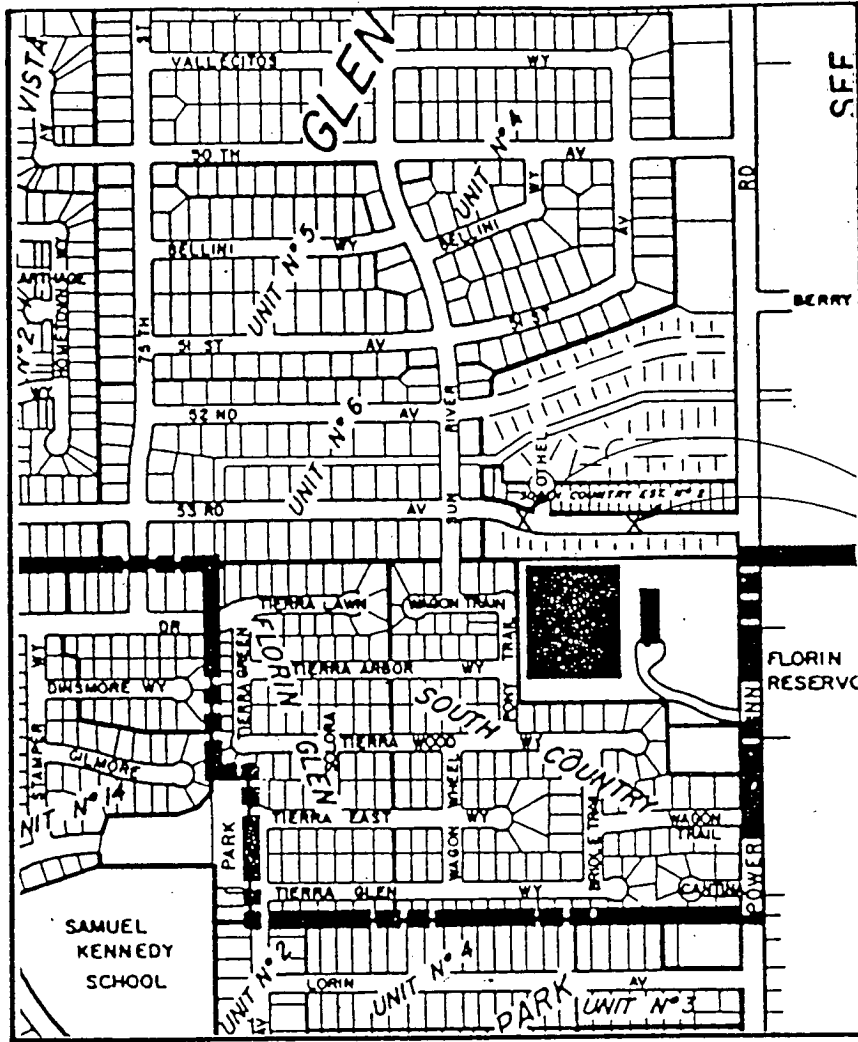


Locations of

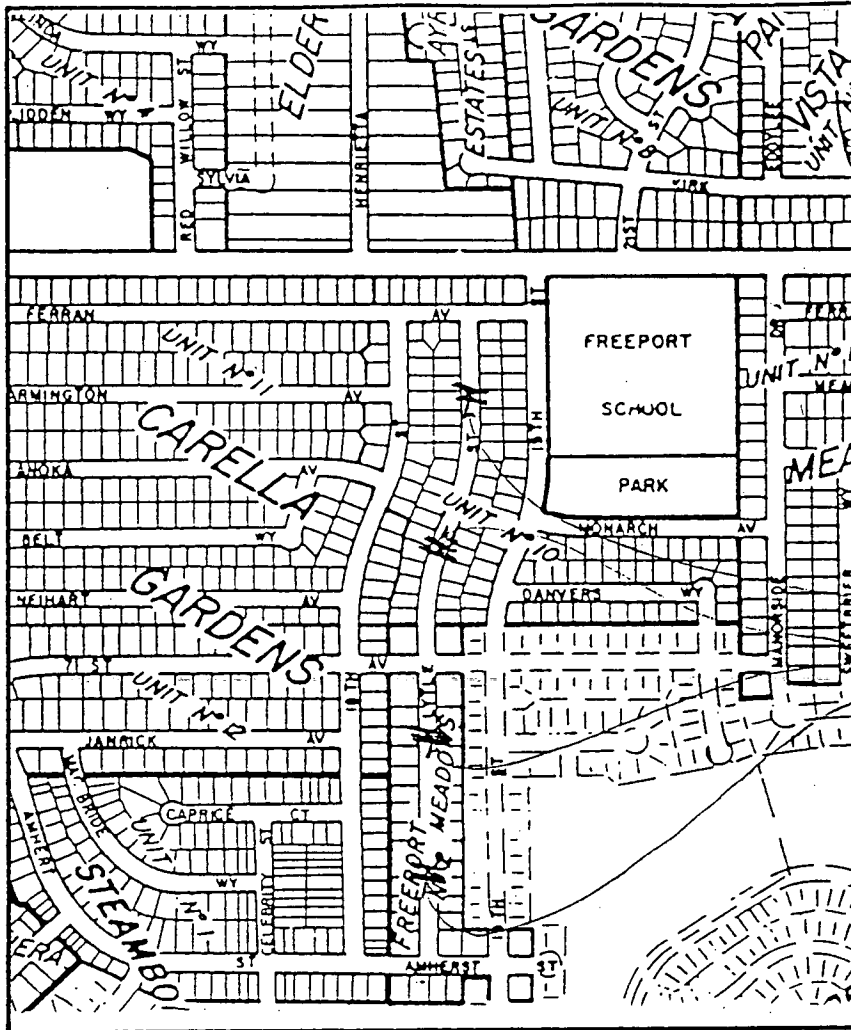


Locations of Undulations

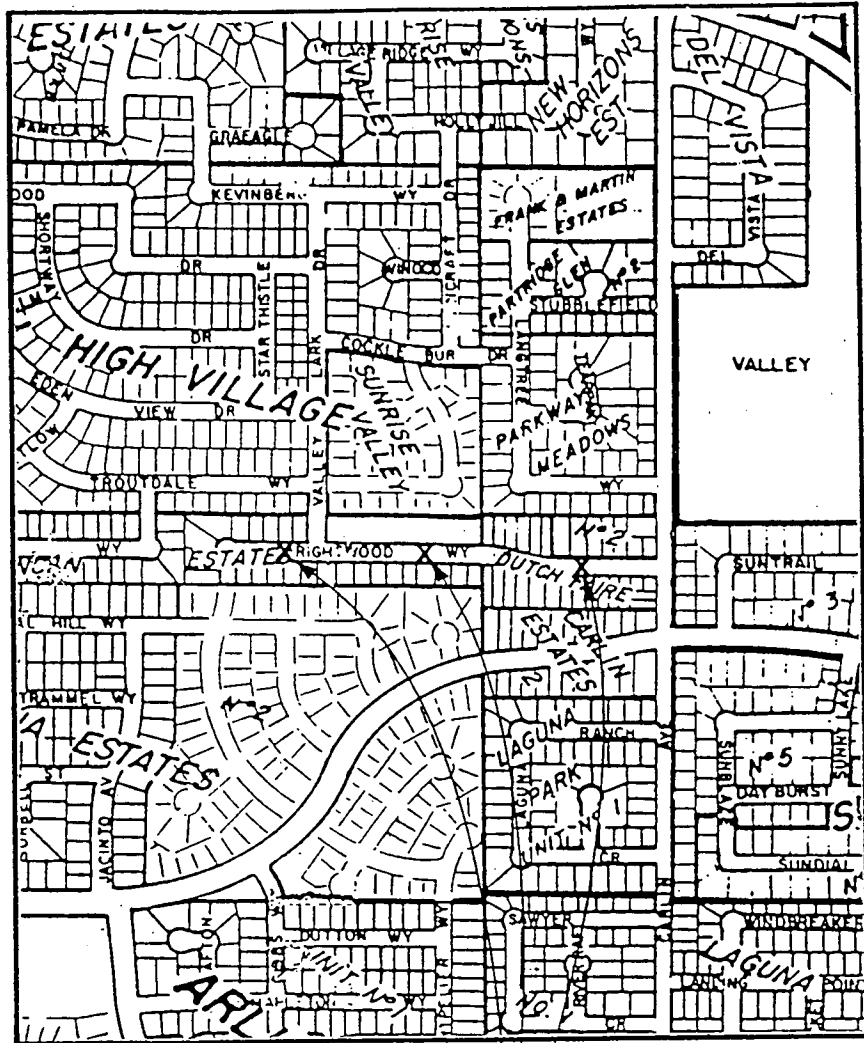


LOCATIONS OF

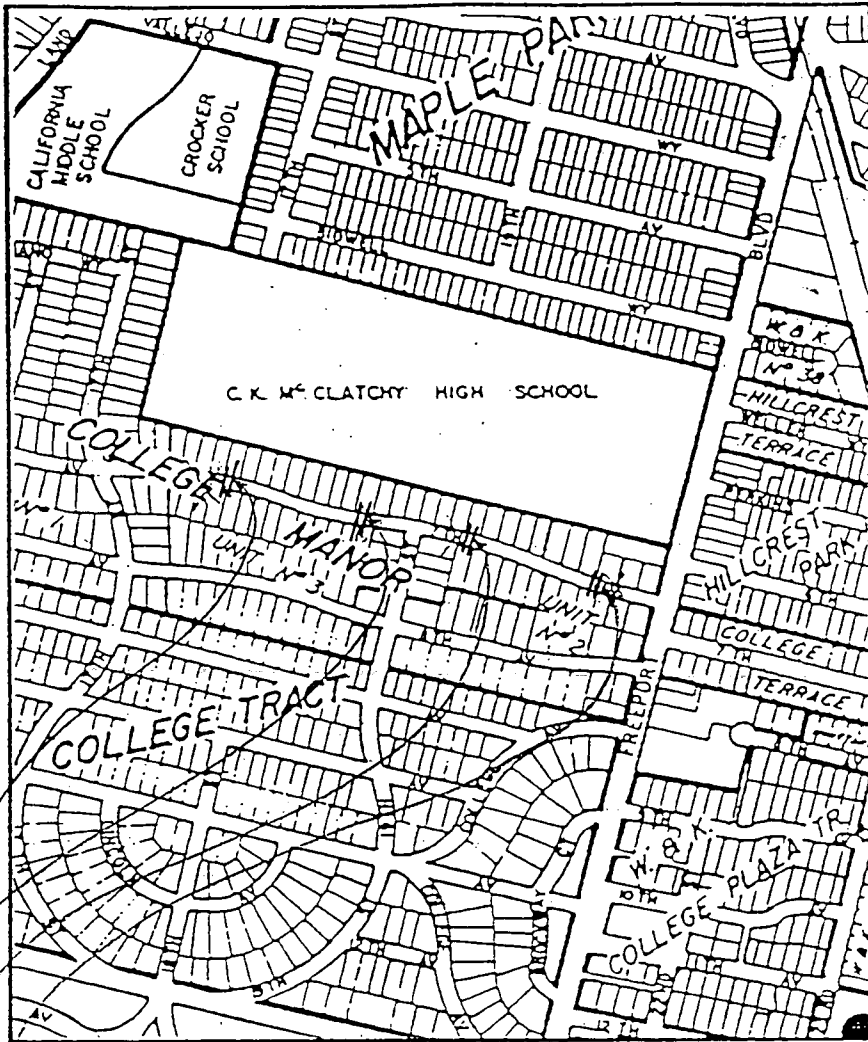


Locations of Undulations

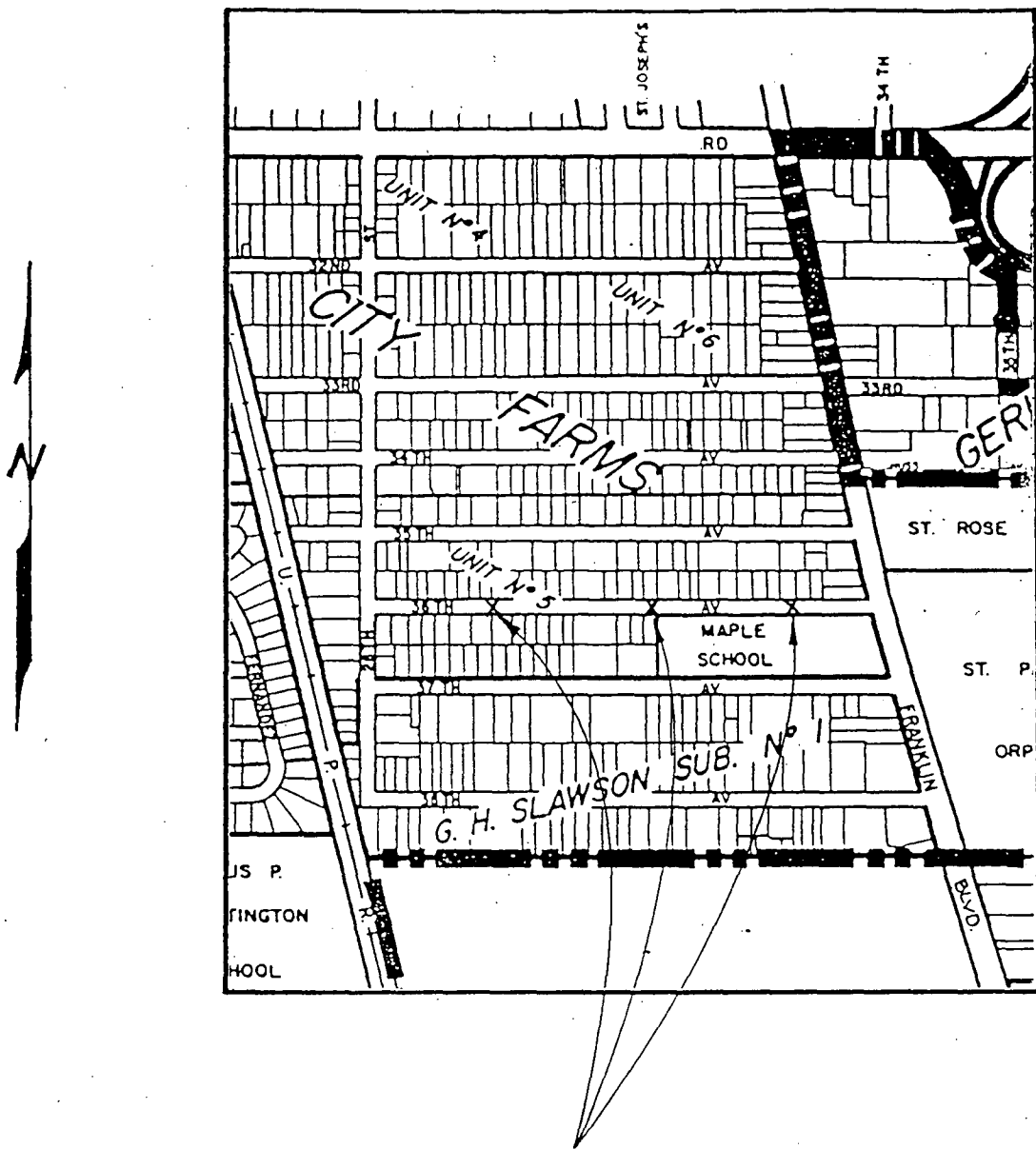


LOCATIONS OF

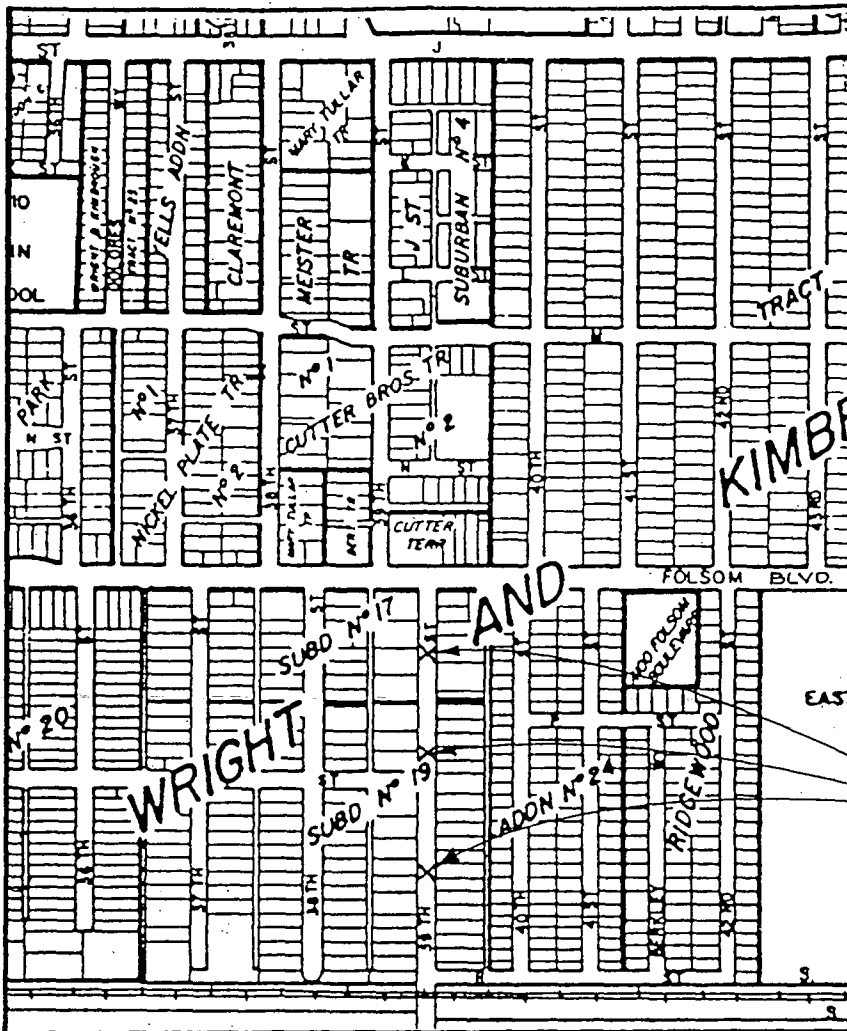


Locations of Undulations

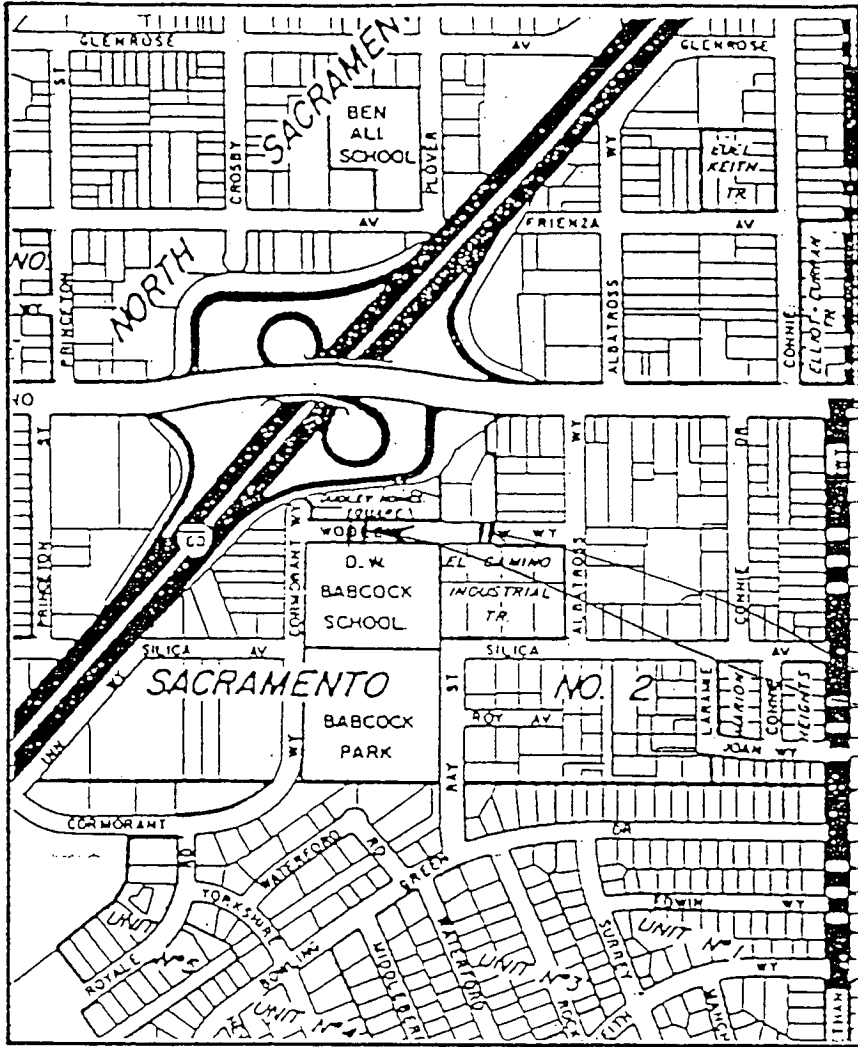


Locations of Undulations
