SUBJECT: Application for SB-325 Funds

SUMMARY

The Department of Public Works has prepared the 1987-88 Fiscal Year Annual Transportation Development Act Claim for \$147,781. Funding is proposed for off-street bikeways along portions of the Sacramento River and Pocket Canal Parkways. Also, the claim includes funding for improvements to the existing Sacramento Northern Bikeway.

BACKGROUND

The Transportation Development Act of 1971 provides that two percent (2%) of a city's or county's SB-325 apportionment will be made available for facilities that provide for the exclusive use of bicycles or pedestrians if such use is approved by the Transportation Planning Agency.

The Sacramento Area Council of Governments (SACOG) is the Transportation Planning Agency for this area. To utilize these funds for Fiscal Year 1986-87, the attached Transportation Development Act Claim (Attachment A) for \$147,781 needs to be submitted to SACOG. Funding for the following projects is proposed:

1. Develop an off-street bikeway along the Sacramento River Levee from Arabella Way south to the City limits.
2. Develop an off-street bikeway along the drainage canals in the Pocket area.
3. Improve the existing Sacramento Northern Bikeway by including park landscaping and three park-like rest stops with bike racks, drinking fountains, benches and restrooms.

FINANCIAL


The claim of \$147,781 will provide local transportation funds for bicycle and pedestrian facility projects as follows:

1. \$50,000 of the estimated total cost of \$1,148,000 for the Sacramento River Bikeway and Parkway.
2. \$50,000 of the estimated cost of \$500,000 for the Pocket Canal Bikeway and Parkway.
3. \$47,781 of the estimated cost of \$525,000 for improvements to the Sacramento Northern Bikeway.

RECOMMENDATION



STATUS OF PREVIOUSLY APPROVED PROJECTS

Briefly describe the status of your most recent approved Transportation Development Act claim including: a) project progress to date; b) income and expenditures to date; and c) an explanation of how current request relates to previous expenditures of funds for these purposes.

Pocket Canal Parkway

Plans, specifications and estimates for the first phase of the Pocket Canal Parkway are complete. The project is expected to be advertised for bid in June. Phase I of the bikeway includes fence relocation, public access improvements, and grading. Paving the bikeway will be part of Phase II for which an additional \$50,000 of TDA funds are requested. To date \$165,000 of TDA funds plus other community park contributions and bike license funds are budgeted for the project.

Sacramento River Parkway

Approximately 50% of the parcels necessary for the development of a bike trail along the Sacramento River in the Pocket Area have been acquired. In addition to the \$365,000 budgeted, \$50,000 of TDA funds is requested. Approximately \$81,500 has been expended acquiring parcels.

Sacramento Northern Parkway

Improvements to the Sacramento Northern Bikeway will include three rest stops with picnic tables, drinking fountains, benches, bike racks, and restrooms. In April, Parks and Community Services will begin public meetings to discuss preliminary designs of the project with the community. In addition to the \$158,000 of TDA funds currently budgeted for the project, \$47,781 is requested.

CSUS/American River Levee Bikeway

In FY 85/86 the City of Sacramento budgeted \$86,000 of SB-325 funds for the CSUS/American River Levee Bikeway. Plans, specifications and estimates are complete, and the necessary permits from the Reclamation Board and the American River Flood Control District have been renewed. The project is expected to be advertised for bids in April. However, the project cost was underestimated \$20,000 and funds will be transferred from the TDA contingency to cover the difference. An estimated \$106,000 is budgeted for the project, \$6,630 of which has been spent administering the project, and preparing plans, specifications and estimates. Currently no additional funds are being requested for this project.

H Street/American River Bikeway

Last year \$50,000 was approved for a project to extend the CSUS/American River Levee project along the levee to Glenn Hall Park. However, due to strong opposition from River Park area residents, staff is currently exploring an alternative route with less impact. The alignment preferred by residents would scale down the project considerably, and the \$50,000 approved funding request should be sufficient.

Miscellaneous Bikeway Improvements

TDA funds were also appropriated in anticipation of miscellaneous bikeway improvements in the City. Approximately \$40,000 has been expended of the \$150,000 budgeted for various signing, striping and paving projects, and about 70 miles of the 170 miles of bikeways proposed in the Bikeway Master plan have been completed. Signing and striping of bike lanes costs approximately \$5,000 per mile. The City is requesting no additional TDA funds for this on-going project.

Southern Pacific Bikeway

Studies are currently being conducted to develop a bikeway along the Southern Pacific Railroad right-of-way. These studies are being coordinated with the State's Steam Excursion Train Project proposal and Regional Transit's Light-Rail Extension Study. Last year \$20,000 was approved for studies and engineering. This year the City will apply for a State Bicycle Lane Account grant and may use \$10,000 of the \$20,000 for matching funds.

Land Park Pedestrian Overcrossing

Due to public controversy over the proposed Zoo expansion studies, a pedestrian overcrossing at Land Park Drive has been put on hold. No funds are requested in addition to the \$20,000 approved for studies and engineering.
