#### **SUMMARY**:

Your dog, a male, black Labrador Mix, has been deemed vicious animals under the Sacramento City Animal Control Ordinance, Section 6.09.101 (b).

On September 7, 1999, 1999, your male, black Labrador Mix, without provocation, attacked and severely bit Brittany Mazzoni, an eight year old child, of 2710 C St., #9, in Sacramento.

On July 31, 1998, your dog, a male, Labrador Mix, without provocation, attacked and severely bit Alexander Morrison-Panullo (six years old at the time), of 182 Baxter Ave., in Sacramento.

Your dog will be put to sleep on October 14, 1999.

If you wish to contest the determination of the Chief Animal Control Officer, you must file a notice of such appeal with the City Clerk's office at 915 I St., Room 300, City Hall, Sacramento, CA., before October 13, 1999. The non-refundable fee for such appeal is \$150.00 per animal. For information regarding the filing fee, please contact the City Clerk's Office at 264-7200.
