SUBJECT: Request for Free Parking by Resources For Independent Living, Inc.

SUMMARY

Resources For Independent Living, Inc., has requested free parking in Lot G for those people attending a fund-raising event on Saturday, August 22nd. This report describes the conditions based on a phone call with a representative of Resources For Independent Living, Inc.

BACKGROUND INFORMATION

On Saturday, August 22nd, Resources For Independent Living, Inc., will be sponsoring a film screening at the Showcase Theater. This is a fund-raising event, and the tickets are \$10 each. The movie is entitled "Inside Moves" and many disabled persons are expected to attend along with the general public. The movie will last from 12:00 noon to 2:45 p.m., and they are hoping to fill all 700 seats in the theater.

It is anticipated that the maximum number of vehicles that would park in Lot G for this event would be 350, and they would be in the garage for about three hours. At 25¢ per hour, the maximum value of this parking would be about \$260. Resources For Independent Living, Inc., is going to offer free parking for this event by validation regardless of the City Council's decision. Therefore, the issue is whether we will bill Resources For Independent Living, Inc., for the cost of the parking or not.


FINANCIAL DATA


