BACKGROUND

Bid No. 1557: Specifications were adopted by the City Council on May 5, 1992 and bids were called for by the City Clerk on May 27, 1992.

Bid No. 1568: Specifications were adopted by the City Council on May 12, 1992 and bids were called for by the city Clerk on June 3, 1992.

FINANCIAL CONSIDERATIONS

Bid No. 1557: Contract amount will be coming from the Fire Department General Operating Equipment Fund, 101-250-2533-4630, with an available balance of \$37,131.13.

Bid No. 1568: Sufficient funds are available in the Convention Center's FY91/92 budget under object codes 4461 and 4630 with a total remaining balance of \$49,070.59.

POLICY CONSIDERATIONS


These recommendations are consistent with the requirements for competitive bidding as detailed in Chapter 57 of the Sacramento City Code.


