Home has been sold. Pest inspection revealed dry rot in the master bathroom shower, which needs to be repaired.

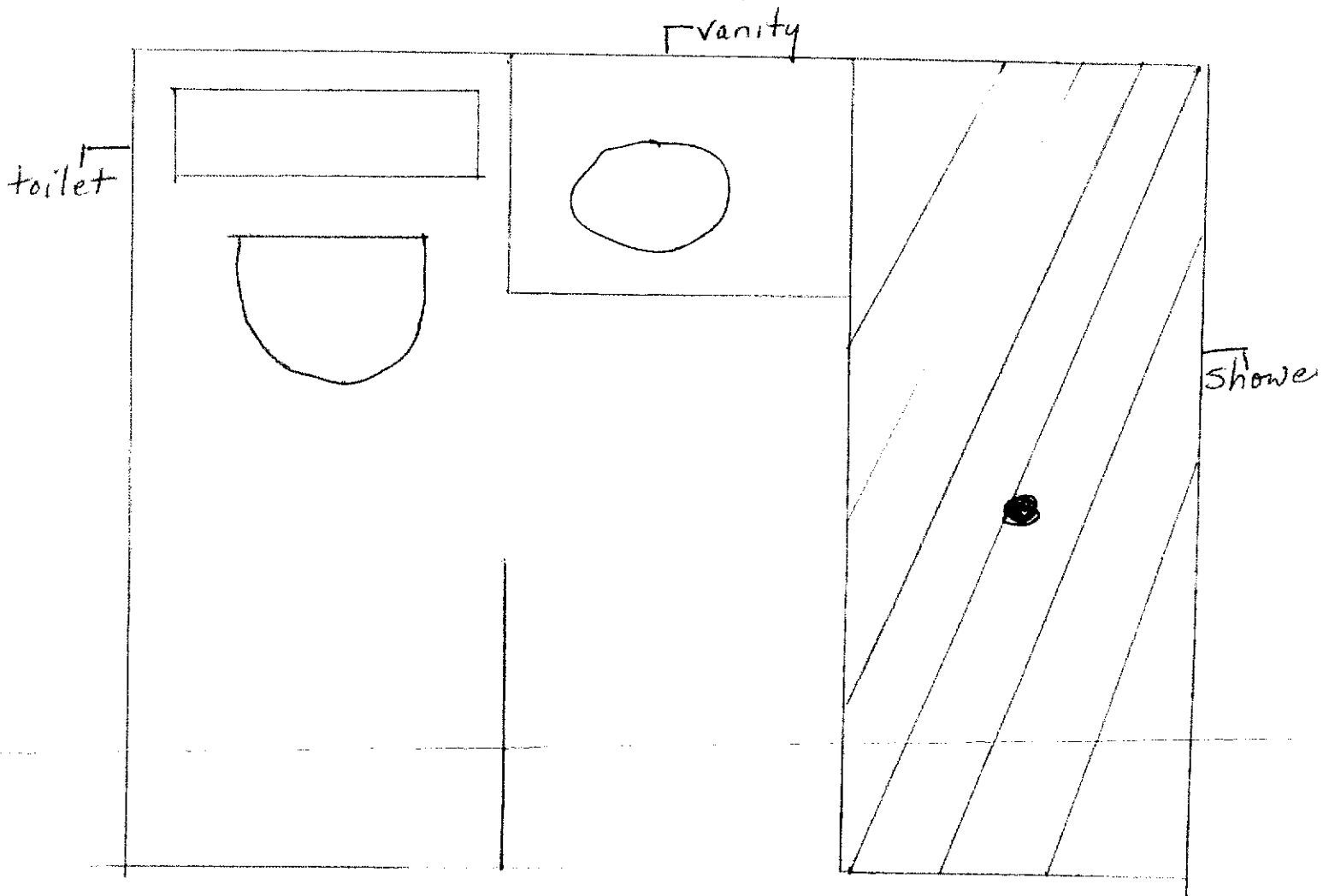
REPAIRS TO BE DONE:
