RESOLUTION AUTHORIZING THE EXECUTION OF AN AGREEMENT WITH SACRAMENTO AREA COMMERCE AND TRADE ORGANIZATION (SACTO) TO PROVIDE SERVICES THAT INFLUENCE THE LOCATION OF NEW PAYROLLS WITHIN THE CITY IN AN AMOUNT NOT TO EXCEED \$60,000 FOR THE FISCAL YEAR 1988-89
